City Attorney Mala Subramanian announced the Council appointed James Boito as interim Fire Chief effective upon the retirement of Chief Calkins.

5. CITY MANAGER REPORT

City Manager Nicole Almaguer reported Phase IV of the Sidewalk Repair Program began the prior week. Public Works has planted 130 new street and park trees. The repaving of Washington Avenue is progressing well, and updates are available on the City website. Activities are scheduled in May to celebrate Older Americans Month. Staff is available to answer questions or assist residents with applying for tax exemptions and renter rebates. The Recreation and Community Services Department is offering summer programs for children, hiring summer staff, and renting picnic spaces.



Mayor Gary asked if anyone wishes to remove items from the consent calendar. Council Members Nason and McQuaid requested removal of Items 7-10, 7-11, 7-12, and 7-13. Vice Mayor Jordan requested removal of Items 7-1 and 7-6. Members of the public requested removal of Items 7-10, 7-12, 7-13, and 7-15.

- Item 7-1: Vice Mayor Jordan requested staff check accuracy of the minutes on Community Development Director Bond's statement on Item 9-2 regarding placing financial responsibility on the City.
- Item 7-6: Vice Mayor Jordan noted the City Manager's announcement that the Police Department received a Gold Award, which indicates our Police Department personnel pays attention to new policies and a good sign of our Police Department culture.
- Item 7-10: Council Member Nason is concerned with the indemnification clause of the agreement. City Attorney Subramanian reported the indemnification provision would require St. Alban's to indemnify the City should the City be sued over the agreement or an event related to the agreement. The language is standard for a contract, and the City's risk authority recommended it. The parties to the contract are the City and St. Alban's. City Manager Almaguer added that the City Clerk's Office sent the proposed agreement to the parties who requested a copy, and she has not received any revisions from the parties.
- Item 7-11: Council Member Tiedemann reported UC Village residents and the residents association have indicated to him that the University of California has used tactics that

make them feel intimidated. The letter is intended to provide and support students' concerns and viewpoint and to apply pressure to UC.

Item 7-12: Council Member Nason reported she will present a proclamation for Italian American Heritage Month in October.

Item 7-13: Council Member Nason expressed concern that employees would not focus on the meaning of Juneteenth if given a day off and preferred to substitute a Juneteenth holiday for two half-day holidays at Christmas and New Year's.

A summary of public comment is as follows: St. Alban's does not feel it can sign the agreement because of the indemnity provision and will seek the Diocese's advice; students living in UC Village do not have a good relationship with the University right now and need help; about one-third of participants live in UC Village; the Free Laundry Program is open to everyone; support for the City funding the Free Laundry Program; support for sending the letter to UC; support for changing the name of Columbus Day; an accurate history of the land needs to be acknowledged; support for recognizing and promoting a Juneteenth holiday; a suggestion for the Council to advocate for the state naming Juneteenth as a holiday; a Juneteenth holiday could attract African Americans to work for the City; the City needs to demonstrate its support for inclusion and equity; Juneteenth should be a paid holiday for City employees; removing Mr. Pinguelo from being on Community Task Force on Policing because he is a member of the Social & Economic Justice Commission (SEJC) is not fair.

A summary of Council comment is as follows: concern about the City providing free laundry services to students living in UC Village; a suggestion to revise the letter to request UC cease activities that may cause students to feel intimidated; a suggestion to include language about the City's willingness to work with UC; a preference to have more conversations before sending the letter; perhaps the Council needs to advocate with the County to include UC students in rent relief programs; agreement with concerns about the financial impact of a Juneteenth holiday on the City and about a focus on the meaning of Juneteenth; Juneteenth is a celebration of freedom just as the 4th of July is; a suggestion to proclaim Juneteenth as an unpaid municipal holiday and to direct the City Manager to meet and confer with labor groups about substituting a paid Juneteenth holiday for an existing paid holiday or two paid half-day holidays.

Mayor Gary announced Item 7-10 is continued so that St. Alban's can perform its due diligence.

City Clerk Anne Hsu presented the staff report. The Chairs of the Arts Committee (AC) and the Parks, Recreation & Open Space Commission (PROSC) will present their proposed work plans. Staff recommends the Council review the work plans, provide comments and/or directions, and approve the work plans.

Aaron Gach, Arts Committee Chair, reviewed proposals for public art, seasonal haiku, collaboration with the Economic Development Committee, the Albany Community Center foyer gallery, Albany Poet Laureate, art in public places ordinance, citywide arts promotion, and municipal art participants.

A summary of public comment is as follows: a suggestion to include indigenous peoples in the description of public art project in support of Black Lives Matter and social justice; a suggestion for artwork that is to be placed on the Ohlone Greenway to pertain to the Ohlone culture.

A summary of Council comment is as follows: a suggestion for the AC to reduce the number of items and prioritize items; support for community involvement in a socially engaged art project; suggestions to highlight the Black Lives Matter artwork at the Bulb and contact El Cerrito about utility boxes; the current and former City Attorneys have reviewed the public art ordinance; concern about the impact of an intern on City finances; funding sources may be available for performance art in the future; the Council can amend work plans after approving them; desire for Council to adopt a policy to include prioritization of the work plan and set a new format for work plans.


City Attorney Subramanian advised that amending the public art ordinance to utilize impact fees for performance art is not possible.

Bryan Marten, Parks, Recreation & Open Space Commission Chair, shared the PROSC's 2019-2021 activities regarding street trees, Albany Hill, Memorial Park, dog parks, pickleball courts, vegetation management, and the upcoming master plan. Proposed initiatives relate to the Parks, Recreation & Open Space Master Plan, Proposition 68 funding, collaboration with nonprofit organizations, maintenance activities, Measure M funding, and AB 2404. A suggestion to include input from the public and indigenous people on interpretive park signage (work plan item 3) can be a great opportunity to potentially include the original occupants and their history.

A summary of public comment is as follows: pickleball courts should be a priority in fiscal year 2022 rather than included in the master plan; hopes that the City and Sogorea Té can collaborate; the PROSC should collaborate with Sogorea Té on projects and programming.

A summary of Council comment is as follows: a suggestion to include play structures for children of all abilities and a skate park; the number of items probably exceeds capacity; perhaps a joint meeting of the Transportation Commission, PROSC, and Climate Action Committee can discuss increasing the size and number of trees to create a tree canopy that positively impacts climate change; the work plan seems to reflect routine items rather than initiatives; support for the PROSC to collaborate with Sogorea Té to incorporate in the work plan.

8-2. Quarterly Financial Update

Staff recommendation: Report is for informational purposes only

Finance Director Heather Rowden presented the staff report. The City is operating at a deficit; however, a number of transfers will be processed at the end of the fiscal year. Staff anticipates ending the year in a neutral position due to Police Department vacancies. Expenses for most departments are tracking with the budget. Risk management is higher than budget, but few expenses are anticipated prior to the end of the fiscal year. Actual revenues and expenses are meeting projections except COVID-19 expenses, which should be reimbursed. Public Works' expenses are currently less than budgeted. Because Public Works budgets for emergencies, it should end the year close to the

budgeted amount or below budget if there are no emergencies. The City needs to begin planning for large expenditures.
