

## CITY OF ALBANY SOCIAL & ECONOMIC JUSTICE COMMISSION

#### **Background**

Each advisory body shall prepare a work plan to be approved by the City Council to ensure tasks being undertaken support the overarching goals of the Council and the City.

This work plan encompasses two fiscal years (July 1 – June 30), starting with the fiscal year following a regular City Council election. The work plan reviews progress on the prior work plan, and identifies items for the next work plan period. The work plan includes items identified as priority projects within the City Council's Strategic Plan.

The newly appointed advisory body shall draft a work plan during the first half of their first year. This will be presented to the Council for approval and implementation will begin in July. Tasks remaining on the previous work plan will be worked on between January – June.

The Social & Economic Justice Commission (SEJC) shall review the work plan mid cycle to identify accomplishments and ensure continued focus on completing tasks.

If a change is needed to the work plan outside of that schedule, the SEJC shall submit a "Request for Amendment to Advisory Body Work Plan" Form for review by the City Council.

Advisory bodies shall review their work plans at the end of the two year term (November/December even calendar year ) and create a status report of their work, including what was completed; what should continue; and what should be dropped. An optional narrative can explain decisions made regard individual items. This summary document will assist the bodies newly appointed at the beginning of the odd calendar year understand their role and enable them to develop their own plan going forward.

#### Purpose of the SEJC

The charge of this Commission is to research, analyze, discuss and evaluate a broad range of data and opinions on social and environmental issues affecting the welfare of the residents of Albany as inhabitants of both a local and a global community, and make recommendations to the City Council on positions and/or actions to take to address these issues.

Recommendations to the City Council shall state the relevance, important and/or particular impact that the issue has on the welfare of the residents of Albany.

- 3) Provide input on outreach efforts regarding information on low income/senior tax exemptions. [WORKED ON; received report on tax exemption and renter rebate application received, and provided input on outreach efforts on low-income/senior tax exemptions, continuing annual updates]

- 3) Develop a model for an Inclusivity/Social Justice impact report to be part of Council review of proposed legislation and initiatives. [COMPLETED; recommended the Council consider a process to ensure inclusivity is considered in staff reports]
- 4) Work with consultant Nicole Anderson & Associates to advance the creation of a Racial Equity Impact Plan [COMPLETED; final draft will be presented to Council]

1) Provide a recommendation to the Council on health and wellness programs to be developed with sugar-sweetened beverage tax revenue where the matter is discussed (Council Study Session). [COMPLETED; provided recommendation to Council]
