**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING  
THE AWARD OF CONTRACT NO. C21-58 TO BKF ENGINEERS TO  
FINALIZE THE PLANS, SPECIFICATIONS, AND ESTIMATE FOR THE  
SAN PABLO AVENUE PEDESTRIAN IMPROVEMENTS PROJECT – PHASE I**

**WHEREAS**, the City of Albany awarded Contract No. C16-18 to BKF Engineers on July 18, 2016, for design of the San Pablo Avenue and Buchanan Street Pedestrian Improvements Project (CIP No. 24001); and

**WHEREAS**, upon furthering said design and reaching approximately 90% completion in 2019, it was discovered that the original project scope exceeded available budget; and

**WHEREAS**, as detailed in the City’s current five-year Capital Improvement Plan, adopted in November 2020, the City of Albany has decided to phase the project to adapt to budget constraints, with Phase I consisting of pedestrian safety and accessibility improvements along San Pablo Avenue between Brighton Avenue to Portland Avenue; and

**WHEREAS**, The Project is determined to be categorically exempt under CEQA and has received a NEPA Categorical Exemption from Caltrans; and

**WHEREAS**, the previous design must be updated and adjusted in order to add recommended changes and remove elements associated with future phases.

**NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council authorize the City Manager to execute Contract No. C21-58 with BKF Engineers in the not-to-exceed amount of \$45,160.00 to finalize the design of Phase I of the San Pablo Avenue Pedestrian Improvements Project (CIP No. 24001) from funds previously appropriated as part of the City’s Capital Improvement Plan.
