**RESOLUTION NO. 2021-79**

**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACT CHANGE ORDER #1 TO CONTRACT C21-22 WITH BAY PACIFIC PIPELINES**

**WHEREAS**, the 2020 Sanitary Sewer Rehabilitation Project – Phase C is included in the City’s Capital Improvement Plan to rehabilitate the City’s aging sewer facilities; and

**WHEREAS**, in 2014 the City entered into a Consent Decree agreement which requires rehabilitation of at least 5,706 linear feet of sewer main per year; and


**WHEREAS**, the City awarded Contract C21-22 to Bay Pacific Pipelines on April 19, 2021, for construction of the 2020 Sanitary Sewer Rehabilitation Project – Phase C (Project); and

**WHEREAS**, EBMUD has identified specific sources of inflow and infiltration in Albany’s sewer collection system including four aging laterals adjacent to the Project; and

**WHEREAS**, staff requested Bay Pacific Pipelines for cost proposals to rehabilitate those four laterals and a 120 linear foot section of sewer main and service laterals similar to age and condition of the deteriorated laterals; and

**WHEREAS**, Bay Pacific Pipelines submitted two cost proposals with a combined cost of \$79,000 which staff deemed to be cost competitive and reasonable.

**NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby authorizes the City Manager to execute Contract Change Order #1 to Contract C21-22 with Bay Pacific Pipelines in the not-to-exceed amount of \$79,000.00, using funds previously appropriated for the Annual Sewer Rehabilitation Program (CIP No. 32000).
