1. CALL TO ORDER/ROLL CALL

2. STUDY SESSION

2-1. Annual Sugar Sweetened Beverage Tax Study Session

Staff recommendation: that the Council:

1. Receive an update on the FY2021 Sugar Sweetened Beverage Tax funded programs
2. Conduct a study session to receive input and recommendations for the expenditure of proceeds from the Sugar Sweetened Beverage Tax
3. Provide a prioritization of items to be funded with the tax proceeds in FY2022

City Manager Nicole Almaguer reported Albany voters approved Measure O1 in 2016 to place a tax on sugar-sweetened beverages. The Council will receive recommendations for the expenditure of tax proceeds from the Social & Economic Justice Commission (SEJC), Transportation Commission (TC), Parks, Recreation, and Open Space Commission (PROSC), and Albany Unified School District (AUSD).

Assistant City Manager Isabelle Leduc presented the staff report. On May 18, 2020, the Council continued funding for the crossing guard program, Safe Routes to School program, and Healthy Me Music and Movement program. The Council also chose to delay allocation of additional funds in order to determine if other needs emerged from the COVID-19 pandemic. Sugar-sweetened beverage tax proceeds are General Fund revenue that the City intends to allocate to specific purposes related to health and wellbeing. Approved expenditures are incorporated into the City's annual operating budget. Staff estimates tax revenue will total \$250,000 in fiscal year (FY) 2022.

Based on the recommendations, there is overlapping interest in using tax proceeds to continue funding for the crossing guard program and the Healthy Me Music and Movement program. Staff anticipates that the Council will receive additional recommendations during the study session. Pending Council direction, staff will provide a more-detailed cost estimate for projects that the Council prioritizes for inclusion in the upcoming operating budget.

Bryan Marten, PROSC Chair, advised that the PROSC recommends allocation of tax proceeds for an education campaign to reduce soda consumption to be incorporated into any programs funded with tax proceeds, planting additional street trees, additional exercise equipment for the Ohlone Greenway, directional signage to parks and open space, the Walk 'n Roll to Shore project, and a water station at Albany Waterfront Park.

Ken McCroskey, TC Chair, recommended funding the crossing guard program with \$160,000, the Safe Routes to School bike safety education program with \$15,000, the Healthy Me Music and Movement program, and the Sidewalk Repair program and/or wayfinding signage.

Cory Dostie, SEJC Chair, indicated that the SEJC recommends allocating \$15,000 for the Free Laundry Program and remaining funds for rent relief to be disbursed at the Council's discretion. Albany CARES, ECHO Housing, or a new program could provide assistance with applications for state aid or provide direct rent relief payments. The SEJC recommends funding rent relief because housing is fundamental to health and a basic physical and mental health issue. The SEJC considered recommendations for a mobile dental clinic, diabetes prevention, and wellness clinics and opposed funding for the crossing guard program as it is related to safety. A rent relief program will build upon the SEJC's and the City's racial equity work.

Frank Wells, AUSD Superintendent, thanked the Council for previously funding the crossing guard and Healthy Me Music and Movements programs.

Alexia Ritchie, AUSD Executive Director of Student Services, requested funding for the Healthy Me Music and Movement program and described the program's goals and educational concepts.

Kim Trutane, AUSD Support Services Coordinator, requested funding to provide swim lessons for under-served students through the All-bany Swims program.

Jackie Kim, AUSD Chief Business Official, requested funding of \$24,100 to fund one All-bany Swims session for 147 students in grades one to three.

A summary of public comment is as follows: support for funding education programs and water bottle filling stations; the Walk 'n Roll to Shore project will be an afternoon of dance, exercise, and music at the Bulb and highlight active transportation routes to the Bulb; a request for \$1,600 for the Healthy Gardens Healthy Community speaker series; the Council needs a specific accounting of tax proceeds; expansion of the free and reduced lunch program, and the Free Laundry Program; encouragement for the Council to explore water service at Waterfront Park; a rent relief program; the Walk n' Roll to Shore project sounds as though it is focused on people who do not have disabilities.

A summary of Council comment is as follows: perhaps AUSD staff can cross-train to fill in for absent crossing guards; a majority of the Council was comfortable using tax proceeds for the crossing guard program; a proposal to reserve approximately \$45,000 of tax proceeds for mental health services; if the City receives federal funding to backfill losses caused by the pandemic, perhaps the Council can discuss withdrawing proceeds not allocated for programs in FY 2021 from the General Fund; active transportation promotes health; support for funding the crossing guard program, bike safety education, and the Walk 'n Roll to Shore project, All-bany Swims, the Healthy Me Music and

Movement program, mental health services; interest in providing dental care and educating pre-adolescents; perhaps the City will provide half the cost for the Walk 'n Roll to Shore project; the County's rent relief program has funding, and a City program would be duplicative; health and wellness services for low-income or homeless residents are a good idea; the Council should discuss another source of funding for the crossing guard program; the Council needs to discuss contributions to the crossing guard and bicycle safety education programs with AUSD and UC; a Safe Routes to School task force may need to be driven at the government level; mental health and wellness services as well as rent relief are priorities, but the City needs to figure out where its resources can do the most good in light of State and County programs; a proposal to fund restrooms on the Ohlone Greenway which may be included in the Parks Master Plan update; more information is needed about criteria for a rent relief program and a partnership for distribution of rent relief funds; water service at Waterfront Park is needed; support for the gardening series, and a matching grant for the Walk 'n Roll to Shore project; the possibility of finding another source of funding for the crossing guard program is low at the current time; hopefully additional street trees will be funded from the utility users' tax increase; the Free Laundry Program has been funded from the Council's discretionary fund; interest in installing water facilities in the San Pablo and Solano corridors; a small bond measure would be an appropriate way to fund water service at Waterfront Park; support for an education campaign; AUSD has resources for an education program to reduce consumption of sugar-sweetened beverages.

Council directed staff to prioritize the Healthy Me Music and Movement program, bike safety education, the crossing guard program, All-bany Swims, Walk 'n Roll to Shore, and the Healthy Gardens Healthy Community speaker series.

2-2. Fiscal Years 2021/22 and 2022/23 Biennial Budget

Staff recommendation: that the Council:

1. Receive a presentation regarding the draft biennial budget
2. Provide any direction to the City's Financial Advisory Committee regarding the draft budget

City Manager Almaguer reported the Financial Advisory Committee will discuss the biennial budget following tonight's meeting, and the Council will have two subsequent discussions of the budget in addition to quarterly updates and a mid-year review.

Finance Director Heather Rowden presented the staff report. The Council will discuss the operating budget, which pertains to the General Fund, Emergency Medical Services (EMS) Fund, Sewer Fund, and Storm Drain Fund. At the next meeting, the Council will discuss budget for Special Revenue Funds, which pertain to tax measures approved for a specific use. The Capital Improvement Plan (CIP) pertains to large projects and purchases by the Public Works Department. At a future meeting, the Council will discuss budgets for debt service and Capital Reserve Funds, which are typically savings accounts.

The City's revenues are composed primarily of property tax, franchise and other taxes, sales and use taxes, and transfers in. Staff anticipates real property taxes will increase 2.4% but business property taxes will decrease. There is no change in the projection for sales tax. In November 2020, Albany voters approved increases in the utility users' tax and the real property transfer tax. Police, Fire including EMS, Public Works, Recreation, and Community Development Departments and the unfunded pension liability incur the majority of expenses. Salaries and benefits are the City's largest expense. Staff proposes new positions for an Assistant to the City Manager and a Deputy City Clerk, miscellaneous staff adjustments, and transfer of the Economic Development Division from the Community Development Department to the Administration Division. Approval of the budget is scheduled for June 21, 2021.

The \$1.5 million deficit budgeted for FY2020/21 likely will not be realized. The proposed budget for FY2021/22 includes a deficit of \$1.8 million due to increasing pension costs and the filling of staff positions in the Police and Public Works Departments. Finance Director Rowden reviewed expenses by department.

A summary of public comment is as follows: sworn Police Officers should not be doing work that is more appropriate for non-sworn Police Officers; hopefully, traffic enforcement will be handled by non-sworn personnel; suggestions to include funding for public showers and mental health services; increasing the Police Department's budget will increase diversity; increased funding is not needed to increase diversity; the budget does not provide specific, detailed information.

A summary of Council comment is as follows: a request for the report to provide more details regarding revenues; a proposal to add staff is concerning in light of the projected deficit; a proposal to track general tax revenues; encouragement for staff to complete the transition in financial systems; year-to-date information as currently reported is not helpful, and an estimate is needed; a request for the priorities that lead to the policy recommendation to increase Administration and for the adequacy of resources for Public Works and financial planning and reporting; a request for the Financial Advisory Committee to consider ways to reallocate public safety funding; the Council needs to discuss public safety funding; a request to include a line item for capital spending in the operating budget; a request for an update of the CIP budget and actuals.

Mayor Gary asked if anyone wishes to remove items from the consent calendar. Vice Mayor Jordan and Council Member Nason removed Item 7-7. Members of the public removed Items 7-14 and 7-16.

Item 7-7: Vice Mayor Jordan reported the campaign supports a plan to reduce emissions by 80% by 2030 and offset 20% of emissions by sequestering 100 million tons per year. The campaign cites a scientific paper in support of the 100 million tons amount, but the paper states the maximum amount is 18 million tons per year. Because the plan is not credible, he did not support adoption of the resolution.

Council Member Nason noted the City is joining with Sonoma and Marin Counties rather than Alameda and Contra Costa Counties.

Sustainability Coordinator Lizzie Carrade reported no jurisdictions in Alameda County have formally supported the campaign. The campaign is sponsored by a nonprofit that is requesting jurisdictions' support.

A summary of public comment is as follows: support for the City and labor unions fairly negotiating employees' time off for the Juneteenth holiday without foregoing any established holidays; suggested revisions regarding Indigenous Peoples in the resolutions; a recommendation to utilize the Progress Pride Flag.

9-1. Ordinance Amending Albany Municipal Code Chapter 8-4 Related to Camping, Hours of Operation for City Property, and Fire Safety

Staff recommendation: that the Council introduce Ordinance No. 2021-08 for first reading

City Attorney Subramanian presented the staff report. In 2019, a decision in the *Martin v. City of Boise* case does not require cities to provide sufficient shelter for the homeless or allow anyone who wishes to sit, lie, or sleep on the streets at any time or any place but specified that an ordinance prohibiting sitting, lying, or sleeping outside at particular times or in particular locations might be constitutionally permissible. The City has adhered to the decision since 2019, but provisions of the Municipal Code need to be updated to comply with the decision.

A summary of public comment is as follows: a request for clarification of the impacts on people living in campers, trailers, and recreational vehicles and whether a homeless person must move to a shelter or may pitch a tent in an allowed location.

3. Propose an amount of work that matches capacity informed by historical analysis,

5. Place items not proposed for work into category pending additional capacity.

Vice Mayor Jordan presented his memorandum. Currently, proposed work plans do not include items that the Advisory Body has neither accomplished nor worked on. This lack of information prevents the Council, staff, and Advisory Body members from improving the process and calibrating the number of work items with capacity. He proposed that a work plan open with a verbatim list of items from the previous work plan and notes of whether an item has been accomplished, worked on, or not worked on. This opening section could include a narrative that provides context and details. Currently, work plan items are not explicitly prioritized even though the template states this. The amount of work needed for work plan items should match capacity based on the historical analysis of work plan items.

Typically, work plan items can be designated as one-time only or recurring. Separating items into these designations in the work plan will highlight items that repeatedly recur and lead to a discussion of whether these items are consuming too much capacity. Capacity will likely limit the number of items, and items proposed but not selected should be listed in a final section of the work plan as a source of work should the Advisory Body complete all other items or not be able to advance items.

A summary of Council comment is as follows: work plans need some flexibility; concern about increasing staff's workload and changing the template when Advisory Bodies have prepared their proposed work plans; a proposal for a work plan template that includes the Advisory Body's purpose, a summary and status report of the prior work plan, lists of regularly scheduled and ongoing items, previous items that the Advisory Body is interested in continuing, new items, and future items; perhaps Vice Mayor Jordan and Council Member McQuaid can develop a work plan template prior to the next meeting.

Mayor Gary announced the item is continued to the next Council meeting.

11-2. Request to Allow the Installation of Temporary Rainbow Crosswalks Adjacent to Albany Unified School District Campuses

Staff recommendation: that the Council direct staff to allow the installation of temporary rainbow crosswalks adjacent to Albany Unified School District campuses

Community Development Director Jeff Bond presented the staff report. Normally, the Council is not involved in the striping of streets; however, this is a unique request pertaining to a significant cause. Albany Pride requests permission to paint colors of the rainbow between the stripes of crosswalks that are located adjacent to AUSD campuses. Albany Pride proposes the use of temporary paint but may later formally request the use of permanent paint. If the Council approves the proposal, staff will work with the proponents regarding details of the project.
