
3. REPORT ON ACTION TAKEN IN CLOSED SESSION, IF ANY

5. CITY MANAGER REPORT

City Manager Nicole Almaguer reported the Codornices Creek webpage has been updated. A food assistance program for low-income residents is available at the Albany Senior Center. Contact Albany CARES to confirm eligibility and register. Reminder to business owners that business license renewal notices were mailed, and confirmation of payment is underway. The Alameda County Organics Reduction & Recycling Ordinance is now in effect, and information can be found at albanyca.org/recycle. Free indoor bins are available to qualifying Albany commercial and multi-family properties businesses, institutions, and multi-family residential properties. The Friendship Club will offer an all-day camp February 18-21, and more information is available on the City website. Recreation & Community Services Department began in-person programs. The Albany dog park is now open daily from 11:00 a.m. to 8:00 p.m. Albany Library and Albany FilmFest will present a free screening on the documentary Barbara Lee: Speaking Truth to Power on February 22, 2022.

A summary of public comment is as follows: thanks to Council Member Gary for speaking about Codornices Village; educating the youth on local history is important; thanks to Albany both for updating the list of homeless services and for Lower Codornices Creek restoration efforts; Berkeley Food Pantry offers in-person and home delivery services to provide free groceries to Albany residents; encouragement for the City to repair streets; concerns regarding Pierce Street maintenance needs and increased crime.

8. PRESENTATION

8-1. Quarterly Financial Update

Staff recommendation: report is for informational purposes only

Finance & Administrative Services Director Heather Rowden presented the second quarter update to the operating budget. City of Albany has collected forty percent of expected revenues, excluding transfers which is a significant portion of revenues, but including property taxes. Expenses have reached fifty-one percent of the budget as expected. Albany received a significant amount of property transfer tax this year and has already exceeded what was budgeted due to increase of real estate transactions during the pandemic across the United States. The year-ending is unpredictable due to changes and unknowns during the Pandemic.

A summary of public comment is as follows: an inquiry regarding the City's budget for Berkeley Food and Housing each year; a question regarding the amount of property taxes contributed by residents on Pierce Street.

Finance & Administrative Services Director Heather Rowden advised that information regarding property taxes contributed would have to be looked up individually. Berkeley Food and Housing is paid for by multiple funding sources, but the contract always goes to Council before approval.

9. PUBLIC HEARING

9-1. Ordinance No. 2022-01 Amending Albany Municipal Code, Chapter 8 ("Law Enforcement") to Add Section 8-22 Entitled "Safe Storage of Firearms" – First Reading

Staff recommendation: that the Council waive reading and approve first reading of Ordinance No. 2022-01, amending Albany Municipal Code, Chapter 8 ("Law Enforcement") by adding Section 8-22 entitled "Safe Storage of Firearms"

City Attorney Mala Subramanian presented the staff report. The Ordinance prohibits keeping a firearm in a residence unless stored in a locked container or disabled with a trigger lock. Exceptions for personal carrying include maintenance and self-defense uses. Flexibility to allow enforcement via a misdemeanor or infraction is included in the ordinance. The vehicle storage component for rifles and shotguns was not included.

A summary of Council comment is as follows: request for the Ordinance to include a more detailed description on the enforcement category; concern about how the Ordinance would be enforced.

A summary of public comment is as follows: a suggestion for the City to monitor the amount of guns owned by residents.

City Attorney Mala Subramanian advised that there could be grounds for citing an individual if they had a legal reason to be in a residence and found a firearm improperly stored. Additional sentences can be included to the Ordinance.

Mayor Jordan advised that there is no uniform gun ownership database and no legal basis for the creation of such database.



10. UNFINISHED BUSINESS

10-1. American Rescue Plan Act of 2021 (ARPA) funding for a Temporary COVID Small Business Assistance Grant Program

Staff recommendation: that the Council approve Resolution No. 2022-09 allocating \$1,000,000 in ARPA funds for a Temporary COVID Small Business Assistance Grant Program

Assistant City Manager Isabelle Leduc presented the staff report. City of Albany has received fifty percent of the allocation of approximately 4.7 million in one-time funds. Council appropriated \$900,000 of ARPA funds to create and market a Temporary COVID Public Assistance Program facilitated by a temporary COVID Community Engagement



Specialist. Staff recommends an appropriation of one million dollars in ARPA funds for a proposed small business grant program. Staff retained the services of California Consulting for research on the use of ARPA funds to support businesses. Economic development plans are primarily in the form of small grants ranging between \$3,000 -\$20,000 from smaller cities, and up to \$100,000 from some larger cities. Funds allocated are intended to provide recovery support to sectors of the economy struggling most to recover from the pandemic. The interest is to develop a distribution plan that would meet the requirements without incurring hardship on businesses. The program would provide grants in the amount of up to \$20,000 but not exceed fifty percent of the business 2019 revenue. Grant awards would be based on tiered criteria. The program will be structured so that necessary documentation is provided at the time of application. Subsequent follow up or reporting will be kept to a minimum to reduce the burden on businesses and the amount of ongoing staff time. Qualifications to apply should include businesses with a City of Albany Business license, a brick-and-mortar presence, and operate as a for-profit business. The program will be structured in two rounds, and assessment based on existing COVID needs of the business community will occur after the first round. Unmet needs could be addressed in the second round, and businesses could reapply if funding was never received. Funds may also be used to implement new long-term safety and access design elements for parklets depending on the outcome of the long-term parklet program. The application will be translated into various languages. Staff will contact businesses most impacted by the pandemic directly.

A summary of public comment is as follows: a question concerning ARPA funding and its purpose; inquiries regarding the amount of money allocated to the City, and how much has been allotted to supporting residents.

Assistant City Manager Isabelle Leduc advised that Albany expects to receive approximately 4.7 million dollars of which fifty percent has been received. As part of the Public Assistance Program and additional funding, Council has appropriated about 1.2 million dollars. Council will have allocated 2.2 million of the fifty percent allocation of ARPA funds received to date.

11. NEW BUSINESS

11-1. Resolution in Support of a Moratorium on the Construction and Expansion of Factory Farms and Slaughterhouses in California

Council Member Gary recommendation: that the Council passes a resolution in support of a moratorium on the construction and expansion of factory farms and slaughterhouses in California

Council Member Gary noted that San Francisco passed a similar resolution. Regulation of factory farming should be undertaken by the City. The memorandum was delivered to the Mayor, who directed what should be presented to the Council.

The Council indicated the Resolution was not vetted by staff, which violates recently adopted Policy.

City Manager Almaguer advised that analysis would be needed if the item is extended to include additional elements.

A summary of public comment is as follows: disappointment regarding the proposal not having been seen by staff; appreciation for Council Member Gary proposing the moratorium; encouragement for Council to consider both the harms of the factory farming industry, and benefits of helping the animal farming workforce to engage with the production of sustainable food systems; the animal farming industry endangers has negative environmental impacts; animals are tortured on factory farms; support for the resolution; giant corporations prevent factory farming regulations; the moratorium gives Albany the opportunity to make a difference; Slaughterhouses expose employees to physical and psychological health challenges; encouragement for Council to support the Resolution; factory farms and slaughterhouses are an abomination to California; passing the Resolution will help disrupt factory farm profits generated from product sales in Albany; City support for the resolution would be both important and symbolic; rejecting factory farms would be an effective course of action to protect the world.

A summary of Council comment is as follows: support for the Resolution; no factory farms exist in Albany; concern about not addressing responsibilities with respect to animal cruelty within Albany; a suggestion for Council to clarify whether California is being asked to put a moratorium on both Golden Gate Fields and meat production facilities; concern regarding broad statements about factory farms being the leading cause of environmental destruction; a suggestion to narrow the statements to support for the Farm Systems Reform Act, and leave state legislation to clarification about the meaning of what is and is not a factory farm; concern about whether the Resolution will be effective; a suggestion for Council to work directly with Senator Skinner and Assembly Member Wicks for legislation insight; a suggestion to call for Senator Feinstein and Senator Padilla to consider being co-sponsors; a subcommittee of the Council may be effective; a suggestion to declare support for the Farm System Reform Act, but defer action on the rest to a future date.

Vice Mayor Tiedemann advised that by Environmental Protection Agency (EPA) definition, Golden Gate Fields would classify as a Concentrated Animal Feeding Operation (AFOs). The Farm System Reform Act includes a moratorium.


Council Member Nason reported she attended the Alameda County Transportation Commission (ACTC) meeting, where ACTC staff discussed setbacks regarding both the Interstate 80/Gilman Street Interchange and San Pablo Avenue multimodal corridor projects.

Mayor Jordan indicated that Interstate 80/Gilman Street project overbudgeting is primarily due to Pacific Gas & Electric (PG&E) undergrounding cost increases.

Mayor Jordan reported he attended a meeting with the StopWaste Energy Council Waste Management Authority Board, during which it discussed the agency's 1,600-acre owned property and efforts for reducing greenhouse pollution. He also attended a meeting of the ad hoc committee of the Alameda County Mosquito Abatement District that is negotiating a new Memorandum of Understanding (MOU) regarding a salary increase for staff.

A summary of public comment: an inquiry regarding Council Subcommittee reports.

Mayor Jordan stated that the Council currently has one ad hoc subcommittee designated. Council Subcommittee members had one meeting with City staff and the contractor to the City regarding a potential revenue measure supporting Advanced Life Support (ALS) services.
