5. CITY MANAGER REPORT

City Manager Nicole Almaguer reported roadway repairs at Buchanan and Jackson Street were underway. Election updates are available at albanyca.org/election, and the next general municipal election is scheduled for November 2022. A free screening for Speaking Truth to Power is scheduled for February 22. The submission window for the Albany Creative Justice Art Project was extended to April 8, visit albanyca.org/arts for more information. Alameda County Health Officers lifted indoor masking requirements for most locations for vaccinated people, including City facilities.



Mayor Jordan asked if anyone wishes to remove items from the consent calendar. Council Member Gary removed Item 7-11, Mayor Jordan removed Item 7-7, and Council Member Gary removed Item 7-8.

Item 7-7: Transportation & Sustainability Manager Justin Fried clarified that several the plans are tailored funding sources that are starting to require them. Staff has discussed being open to new projects as identified in the analysis, but several high injury network corridors are some in which staff has projects in the queue.

Item 7-8: City Attorney Mala Subramanian explained that direction from the Council would be needed to include data and language of solidarity for other cities.

A summary of public comment is as follows: AB (Assembly Bill) 2764 calling for the No More Factory Farms campaign has been introduced in the California State Legislature; inquiries regarding subcommittee training

City Manager Almaguer advised that appointees receive online training provided to all advisory bodies at the beginning of the two-year term. Training includes topics of Brown Act, ethics, and other essential items for the productive participation of all advisory body members. All new appointees receive a link to the recorded training and meet with the staff liaison to the respective advisory body for an orientation.

8. PRESENTATION

8-1. Annual Comprehensive Financial Report (ACFR) and Annual Audit for FY 2020-21

Staff recommendation: that the Council:

- 1. Receive presentation of the results from the City's independent auditor's examination of the City's financial reports for fiscal year ending June 30, 2021;
- 2. Accept and file the reports; and
- 3. Adopt Resolution No. 2022-14 to reallocate and appropriate surplus General Fund fund balance

Chavan & Associates LLP Consultant Paul Pham presented financial results for the June 30, 2021, audit. Noncurrent liabilities increased mainly due to the City's Retiree Benefits Plan. The City had increases in contributions and taxes. Increased revenues on the expenditure side were used to provide additional services in general government, police, and fire. Net position decreased to \$24.2 million. The ending fund balance increased by \$2.3 million. The City reclassified two fiduciary funds from agency to custodial funds, increasing beginning net position. One finding was reported, which is improvement from previous years. Overall, Albany is in a healthy net position.

A summary of public comment is as follows: a request for audit reports to be presented to the Financial Advisory Committee prior to Council meetings; questions regarding unfunded pension liabilities; inquiries about budget amounts for public safety; a question regarding a direct audit of Berkeley Food and Housing spending for winter 2020.

Finance & Administrative Services Director Heather Rowden advised that a more in-depth analysis of the financial statements will be presented to the Financial Advisory Committee at the next meeting. The responsibility of the auditor is ensuring fairly presented financial statements.

Chavan & Associates LLP Consultant Paul Pham explained that the City is in a pool, which has its own actuaries that evaluate overall liability of the pension plan. Calculation is the City's proportionate share of the pool. Additional contributions and trusts will help address the net pension liability reported. Interest rate, return on investment, and discount rate are interchangeable terms. Net pension liability is a net of the assets remaining for a plan.

Finance & Administrative Services Director Heather Rowden clarified that a restricted fund balance includes fund balance amounts constrained for a specific purchase. Measure B, Measure BB, and Measure F money from the Alameda County Transportation Commission (ACTC) is restricted because it must be used for road improvements, bike and pedestrian improvements, and paratransit. Unrestricted funds give the Council the ability to allocate.

A summary of Council comment is as follows: a preference for more discussion of reserve funds in the context of the budget; a suggestion to change the PDF title to "City of Albany."; only one audit finding for the City is impressive; asset reserve funding should be deferred for review; a preference for a longer timeline between when the report is received and the Council meeting; a suggestion to include a glossary of terms; suggestions to add a note explaining the increase in Other Post-Employment Benefits (OPEB) liability, .

Moved by Council Member Nason, seconded by Vice Mayor Tiedemann, to fund the climate action reserve fund at the amount recommended by staff based on revenue received, and increasing the allocation for a contribution to CalPERS by \$500,000 including the \$500,000 budgeted for a total of \$1,000,000, and referring the consideration of the rest of potential surplus allocation reserves to the Financial Advisory Committee to consider and make a recommendation.

10-1. Request for Qualifications (RFQ) – Racial Equity Survey

City Council Ad Hoc Committee recommendation: That the Council:

1. Authorize issuance of a Request for Qualifications (RFQ) to be submitted with 45 days to firms to perform a survey regarding racial equity,

- Establish a Council ad hoc committee to advise on outreach marketing the RFQ and evaluate responses to the RFQ with staff according to the criteria in the RFQ, and
- Refer the responses to the Social and Economic Justice Commission to evaluate via the same criteria and subsequently make a recommendation to the City Council

Mayor Jordan presented the staff report. This document was developed by the Ad Hoc Committee designated by Council with input from staff and the Social & Economic Justice Commission. Several changes were made to focus specifically on the survey instead of ancillary services. The company that performs the survey may have ideas about the type of priorities suggested in survey results.

Attorney Mala Subramanian advised that the language in the RFQ Submittal Requirements should be changed to clarify that preference will not be given to consultants based on racial considerations in relation to the Proposition 209 Constitutional Amendment prohibitions previously discussed.

A summary of public comment: appreciation for the work accomplished; numerous disenfranchised groups within the community should be represented on the committee; the Council should hire a multicultural firm; a suggestion to include Ohlone culture.

A summary of Council comment: a suggestion to keep the same subcommittee and bring the recommendation directly to Council; appreciation to the Ad Hoc committee for the work achieved; efforts will be made by SEJC to avoid using racially charged, dehumanizing language in the future; suggestion that reviewing the RFQ will be adequately handled by the Council ad hoc committee and recommend directly to Council; support for referring the responses to SEJC for evaluation.

The Council reached a consensus to rephrase the first element in the RFQ Submittal Requirements to "experience relating to potential survey respondents from a diversity of cultures."






