RESOLUTION NO. 2022-16

A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING APPLICATION FOR, AND RECEIPT OF, DEPARTMENT OF RESOURCES RECYCLING AND RECOVERY SB 1383 LOCAL ASSISTANCE GRANT PROGRAM

WHEREAS, The Short-Lived Climate Pollutant Reduction Act of 2016 (Senate Bill 1383) is a state mandate requiring diversion of 75% of organic waste from landfills and recovery of 20% of edible food statewide by 2025; and

WHEREAS, on December 6, 2021, the City Council adopted Ordinance No. 2021-11 amending Section 15-2 of the Albany Municipal Code, opting into the Alameda County Organics Reduction and Recycling Ordinance (ORRO); and

WHEREAS, local jurisdictions are the primary entities responsible for implementation and enforcement of SB 1383 requirements; and

WHEREAS, The Department of Resources Recycling and Recovery (CalRecycle) is administering a one-time, non-competitive grant program meant to provide aid in the implementation of regulations adopted by CalRecycle pursuant to Chapter 395, Statutes of 2016 and SB 170 Budget Act of 2021; and

WHEREAS, awarded grant funds will be used to fund implementation of SB 1383 in the City of Albany; and

WHEREAS, on January 18, 2022, the City Council adopted Resolution No. 2022-04: A Resolution of the Albany City Council Authorizing Application For, And Receipt Of, Department of Resources Recycling and Recovery SB 1383 Local Assistance Grant Program; and

WHEREAS, this Resolution will supersede Resolution No. 2022-04. This Resolution specifies a term of five years during which the authorizations granted to the City Manager herein are in effect.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorizes the City Manager to submit to the Department of Resources Recycling and Recovery (CalRecycle) a SB 1383 Local Assistance Grant Program application and if awarded to execute all associated grant agreements and documents necessary to implement and closeout the SB 1383 Local Assistance Grant Program for a period of five years from the date of Resolution adoption.
