A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING A FINANCIAL CONTRIBUTION AND CO-SPONSORSHIP FOR UPCOMING SOLANO AVENUE EVENTS AND PROGRAMS TO SUPPORT THE BUSINESS COMMUNITY

WHEREAS, the City Council Strategic Plan identifies advancing economic development and vitality as a priority; and

WHEREAS, the Solano Avenue Association holds a number of events and programs to support the local business community; and

WHEREAS, the COVID 19 pandemic has impacted the community at large, including our local businesses and local business support agencies; and

WHEREAS, the Solano Avenue Association has requested a \$57,500 financial contribution and co-sponsorship from the City of Albany for upcoming events and programs; and

WHEREAS, the City has received American Rescue Plan Act Funds in the total amount of \$4,711,702, and this funding allocation would qualify under the Public Health and Economic Impacts spending category; and

WHEREAS, to date, the Albany City Council has allocated a total of \$2,217,000 of the total amount of American Rescue Plan Act Funds, including a grant program for local businesses as detailed in the following table:

NOW THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorizes the financial contribution and co-sponsorship of upcoming Solano Avenue Association events and programming in the amount of \$25,000 of which \$15,000 funded from City Council Discretionary Funds and \$10,000 funded from the American Rescue Plan Act Funds; and

BE IT FURTHER RESOLVED, that the Solano Avenue Association shall work with City of Albany public safety personnel on their events and programming.
