# 5. DISCUSSION & POSSIBLE ACTION ON MATTERS RELATED TO THE FOLLOWING ITEMS:

**5-1. Plans for Marin Avenue Pavement Project –** Staff will present plans for the mill and overlay reconstruction of Marin Avenue between Cornell Avenue and Key Route Boulevard.

**Recommendation:** Recommend that City Council approve plans of the Marin Avenue Pavement Project as presented by staff.

Carrillo presented the staff report.

## The Commission requested the following clarifications:

- The design includes triple-four striping for crosswalks at Talbot Avenue, and the yellow coloring indicates a school crossing.
- Stop lines painted before the crosswalks at the Evelyn Avenue intersection are a design error and will be removed.
- The striping design at Masonic Avenue needs additional adjustment to incorporate the previously approved design elements.
- Staff can examine the possibility of displaying left-turn bicycle road markings at the Masonic Avenue intersection.
- The elevation changes at intersections necessary for ADA crossings will extend outwardly to provide gradual transition.
- The existing pavement is generally less steep than in Phase 2.
- The option for a protected bike lane is maintained with the current design.

#### The following PUBLIC COMMENTS were offered by Jeremiah Pinguelo:

 Inquiries regarding the meaning of two bicycle road markings before the crosswalk at Masonic Avenue, school crossing signage, striping colors, and lightemitting diode (LED) push-button crosswalk system prices.

Fried advised that yellow is the standardized coloring for school zone crosswalk markings in the State of California.

Hurley indicated that installations for LED push-button crosswalk systems in the City

**5-2. Potential for Lowered Speed Limit on Solano Avenue –** Staff will present traffic survey data for Solano Avenue and a discussion of considerations for reducing the speed limit on Solano Avenue.

Recommendation: Provide comments to staff.

Fried presented the staff report.

### The Commission requested the following clarifications:

• Implementing 15 mph advisory signage in conjunction with 20 mph regulatory signage is an option.

## The following PUBLIC COMMENTS were offered by Jeremiah Pinguelo:

• Appreciation for the item; a preference for a 5-10 mph speed limit on Solano Avenue; and a suggestion to paint the speed limit on the street.

#### The Commission made the following comments:

- Appreciation to staff for the report.
- The safety of individuals walking and biking along Solano Avenue should be prioritized.
- Support for reducing the speed limit to 15 mph, but 20 mph is an improvement.
- The speed limit is one component of the greater design to work on if the City intends to have long-term in-street dining.
- Reducing the legal speed limit to 20 mph should be enforced.
- The 15 mph advisory at the parklets should continue.
- A 20 mph speed limit near Peralta Avenue would create a safer environment for pedestrians crossing the street.
- Signage may not change behavior, but they will help enforce it.

Posting speed limits of 20 mph and advising 15 mph sporadically seems

Signage clutter needs to be avoided.
