**WHEREAS**, the Arts Committee is requesting an additional allocation of Art in Public Places funds of \$1,500 to cover the cost of 3 expert panelists to review submission received.

**NOW, THEREFORE, BE IT RESOLVED,** that the Albany City Council allocates Art in Public Places funds in the amount of \$1,500 to cover the cost of stipends for 3 panelists with expertise in public art to review submissions received for the Albany Creative Justice Art Project.
