**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING
THE APPROPRIATION OF RESERVE FUNDS FROM THE FIRE DEPARTMENT
AND EMERGENCY MEDICAL SERVICES TO PURCHASE NEW EMERGENCY
COMMUNICATIONS EQUIPMENT AND MONITOR/DEFIBRILLATORS**

WHEREAS, the Albany Fire Department is an Advance Life Support and ground ambulance transport agency in Alameda County; and

WHEREAS, the Albany Fire Department uses monitor/defibrillators as part of their care and treatment of every patient when providing emergency medical care; and

WHEREAS, the Albany Fire department utilizes emergency communications equipment while on emergency incidents, when deployed to Statewide mutual-aid fire incidents and when conducting routine business outside of the station to stay on contact with other responders and our dispatch center; and

WHEREAS, the purchase of new emergency communications equipment and monitor/defibrillators helps the Albany Fire Department to fulfill The Albany City Council's Strategic Plan Goal 1 Objective 4 "Increase Public Safety and Health".

NOW, THEREFORE, BE IT RESOLVED, the Albany City Council hereby authorizes the appropriation of \$261,673.74 from the Fire Department Reserve Fund (2205) and \$106,852.43 from the Emergency Medical Services (EMS) Reserve Fund (2204) for the purchase of new monitor/defibrillators and emergency communications equipment; and

BE IT FURTHER RESOLVED, the Albany City Council authorizes the City Manager to execute an agreement to purchase the following using the appropriated reserve funds: three LIFEPAK 15 V4 fully equipped monitor/defibrillators from Styker Medical for \$106,852.43; 25 Motorola portable radios from Motorola Solutions for \$255,108.08; and two KNG-M150RM mobile radios from Silverado Avionics for \$ 6,565.66.
