7	WHEREAS, the residents of Albany have recognized the need for safe, passable
8 9	sidewalks to improve walkability throughout the City's entire network; and
10	WHEREAS, under Section 5610 of the California Streets and Highways Code and per
11	Albany Municipal Code Section 14-1.5b, property owners and persons in possession of
12	property are required to maintain adjacent public sidewalks in a safe condition; and
13	
14	WHEREAS, in November 2016, Albany voters approved Measure P1, a parcel tax for
15	the purposes of publicly funding repairs to the City sidewalks; and
16	
17	WHEREAS, in November 2020, the City Council approved Resolution No. 2020-108,
18	adopting the FY2019/20 – 2023/24 Capital Improvement Plan and appropriating funds for the
19	first three fiscal years of the Plan, including funding from the Sidewalk Parcel Tax Fund (1305)
20	for the Annual Sidewalk Rehabilitation Program (CIP No. 22000); and
21	
22	WHEREAS, on May 2, 2022, the City Council authorized staff to advertise Phase 5 of
23	the Sidewalk Rehabilitation Program; and
24	
25	WHEREAS, on June 7, 2022, the City received and opened eight (8) bids for the above-
26	mentioned project; and
27	
28	WHEREAS, MCE Corporation is the lowest responsible and responsive bidder for the
29	construction of Phase 5 of the Sidewalk Rehabilitation Program.

**NOW, THEREFORE, BE IT RESOLVED,** that the Albany City Council hereby authorizes the City Manager to award Contract No. C22-14 to MCE Corporation for construction of the Phase 5 Project for the not-to-exceed amount of \$249,450 using funds previously appropriated for the Annual Sidewalk Rehabilitation Program (CIP No. 22000).
