5. CITY MANAGER REPORT

City Manager Almaguer reported the nomination period for candidates interested in seeking office for City Council or the Board of Education is now open, and information is available at albanyca.org/election. An informational session on a change to the City's election method to rank choice voting is scheduled for July 25, 2022. Barricades placed as a prevention measure for the Albany Fire on June 26, 2022 have been removed surrounding the public properties on the hill. Private properties which were where the primary fire occurred remains less accessible while the City works with the property owners to identify and mitigate hazards resulting from the fire. A ceremony welcoming the City's new Sculpture Loan Program art piece to the Ohlone Greenway is scheduled for July 21, 2022. The Household Hazardous Waste Collection Event had a great response, and all appointments were filled. Information can be found at stopwaste.org/athome. Sidewalk repair is scheduled to begin July 25, 2022, and last through October 2022. Repairs to park services is now complete. National Night Out is scheduled for August 2, 2022, and details can be found at albanyca.org/nno.

6. GOOD OF THE CITY/PUBLIC COMMENT

Mayor Jordan opened the Good of the City.

A summary of public comment is as follows: a question regarding sidewalk ADA (Americans with Disabilities Act) accessibility; the functionality of ADA button in the men's restroom at Memorial Park; Berkeley Food Network and Berkeley Food Bank are available for Albany residents with valid identification; the name "Lisjan" has been mispronounced during the Land Acknowledgement; an inquiry regarding the legality of approving the six-month service language in the City Manager Agreement.

City Manager Almaguer advised that the sidewalks will be compliant with ADA standards throughout the project.

Council Member McQuaid extended congratulations to the four new Eagle Scouts of Troop 14: Ben Cabanatuan, Alex Ferguson, James Mercer, and Benjamin Piluso Burns.

Mayor Jordan asked if anyone wished to remove items from the consent calendar. Council Member Gary removed Items 7-3, 7-8, 7-10, and 7-12. A member of the public removed Items 7-1 through 7-11.

Item 7-3: Heather Rowden, Finance & Administrative Services Director, indicated that Berkeley Food & Housing is paid as they bill the City generally within a month or two of their services.

Item 7-8: Heather Rowden, Finance & Administrative Services Director, explained that the Community Development Block Grant funds are federal funds provided to the county and then allocated to cities based on different projects. The City has obtained approximately \$45,000 for addressing homelessness and some funding for ADA sidewalk compliance and construction.

Item 7-10: Mark Hurley, Public Works Director, indicated that Swinerton Management was selected through a competitive process. Contractor performance is factored into a qualifications-based selection.

Item 7-12: Mark Hurley, Public Works Director, explained that the location of the rainbow crosswalk was selected because the project is within the scope of the 2022 pavement project that can be worked on at the same time. Thermoplastic is a long-lasting, standard striping material.

A summary of public comment is as follows: a question about the frequency of when Berkeley Food and Housing gets paid; a request for more information about the 19th Amendment; and a question regarding the resumption of in-person meetings; a preference that a portion of Community Development Block Grant (CDBG) funds be allocated to universal basic income; support for proposed thermoplastic crosswalk on Cornell Avenue and Solano Avenue; and support for virtual meetings.

A summary of Council comment is as follows: a request that Council consider further discussion with Berkeley Food & Housing prior to authorizing allocation of the funds; universal basic income may not fall within the scope of CDBG.

9. PUBLIC HEARING

9-1. Public Hearing to Consider Adoption of the San Pablo Avenue Specific Plan and Related Documents Including Amendments to the General Plan and the Addendum to the General Plan Environmental Impact Report; Adoption of Design Guidelines and Objective Standards, and Community Benefits; and First Reading of Ordinance No. 2022-03 to Adopt Amendments to the Zoning Ordinance

Staff recommendation: that the Council hold a public hearing to adopt the San Pablo Avenue Specific Plan and related documents. This includes the following actions:

- 1. Resolution No. 2022-87 (Attachment #1) to adopt amendments to the General Plan and the Addendum to the General Plan Environmental Impact Report (EIR); and
- Resolution No. 2022-88 (Attachment #2) to adopt the San Pablo Specific plan, Design Guidelines and Objective Standards, and Community Benefits; and
- 3. Ordinance No. 2022-03 (Attachment #3) to adopt amendments to the Zoning Ordinance, related to the Specific Plan First Reading

CEQA: An Addendum to the General Plan Environmental Impact Report has been prepared pursuant to Section 15164 of the CEQA Guidelines

Community Development Director Jeff Bond presented the staff report. The San Pablo Avenue Specific Plan is intended to update policies to support a vision for San Pablo

Avenue, align Zoning and General Plan, and to address racial equity and economic diversity.

Jean Eisberg, Lexington Planning, highlighted the plan's vision, objectives, planning process, timeline, and components. The vision of the plan is to transform San Pablo Avenue into a walkable, transit-oriented, mixed-use urban boulevard. The Specific Plan aims to fulfill the policy objectives for San Pablo Avenue, as stated in the General Plan and General Plan Policies. The project recommends changes to the zoning ordinance. specifically around amendments to the zoning standards to help facilitate the vision. Planning boundaries extend from city boundaries from Berkeley to El Cerrito, and then to the east and west to Kains and Adams Street. Over four hundred community members engaged in the virtual open house. Ten Planning and Zoning Commission study sessions and public hearings were used to discuss various aspects of the plan and work with the community. On June 22, 2022, the Planning and Zoning Commission recommended that Council adopt the plan and the related implementation. Key chapters of the plan include Land Use, Urban Design, Infrastructure Mobility, and Implementation. A series of appendices highlight zoning changes. Several map amendments are proposed under the plan and related implementation, including a General Plan Land Use Designation change. Several images have been added to the plan to illustrate how the projects might look. Staff will return with an ordinance instead of a resolution on community benefits at a future date. An addendum has been added to the General Plan Environmental Impact Report (EIR), which evaluates all California Environmental Quality Act (CEQA) topics and includes technical studies on traffic, air quality, greenhouse gas (GHG) emissions, noise, cultural resources, and utilities/infrastructure.

City Attorney Mala Subramanian advised that the language related to the inclusionary housing requirement under the government code is required to be done by ordinance.

Community Development Director Jeff Bond indicated that approval is expected for a building code standard of twenty percent of the spaces being built and prepared to accommodate electric vehicles. The plan mainly pertains to private property in the zoning requirements. There are no current requirements for wireless infrastructure, but any new buildings would likely have the latest technology. There is nothing about the plan that precludes another significant affordable housing project in the City. The zoning changes may increase the chances of attracting a non-profit housing developer.

A summary of public comment is as follows: support for the plan; a suggestion that the nodes from Solano Avenue to the south be one long node with more density; a variety of housing market rates and affordable housing are needed; a request for a better explanation of affordable housing; concern about insufficient parking; inquiries regarding cultural resources and how it was reviewed, the selection of public art, and the average amount spent on ADUs (accessory dwelling units); the developments do not appear to address the homelessness crisis; a question as to why the community benefits portion has been tabled to a later discussion; the proposed revisions to the General Plan will have a significant adverse impact on the neighborhoods immediately adjacent to San Pablo Avenue; proposed revisions to the General Plan and Municipal Code completely

change the standards for building height and eliminate the daylight plane requirements; increased safety on San Pablo Avenue is needed; questions about whether San Pablo Avenue will be metered parkings, and if there are plans for a homeless shelter in Albany; a request for additional detail regarding the change to the Goodwill property; the plan is a framework for moving forward; support for transit oriented development; it is misleading to state that the zoning ordinances have been in place for decades and unchanged; opposition to lifting the daylight plane; a request that Council reconsider the significant impacts that the proposal will have on residents.

Community Development Director Jeff Bond noted the plan does not change existing affordable housing requirements. 7.5% of the units are required to be very low-income and another 7.5% are required to be low-income.

Mayor Jordan advised that the community benefits portion has been moved to a later session due to state law requiring it to be adopted by ordinance rather than resolution.

Jane Lin, Lexington Planning, indicated that a solar shading study was conducted using existing zoning and proposed zoning to explore the extremes of the two different solstices and equinox.

A summary of Council comment is as follows: the plan establishes the necessary preconditions for housing to be built; concern about having no parking requirement, and a preference to have at least 0.5 parking spaces per unit; opposition to allowing individuals with vehicles to not pay the extra fee for parking and negatively impact neighbors; support for not forcing individuals to pay for parking that will not be used; a request for a future discussion regarding how parking in the neighborhoods will be managed.



9-2. Public Hearing to Authorize Collection of Delinquent Garbage Bills by Placement on the Alameda County Property Tax Roll

Staff recommendation: that the Council adopt Resolution No. 2022-89, confirming the special assessment list for delinquent residential garbage bills, and authorizing the delinquent charges be placed on the Alameda County property tax roll

Elizabeth Carrade, Sustainability Coordinator, presented the staff report. The resolution confirms the annual special assessment list for delinquent residential garbage bills and authorizes the delinquent charges to be placed on the county tax rolls. Waste Management is required to continue regular weekly residential collection services even if customers do not pay. In 2013, Council passed an ordinance authorizing collection of delinquent garbage bills by placement on the Alameda County tax rolls. Accounts over ninety days past due in January of this year received a minimum of four delinquency notices and a final request for payment from the City. Unpaid balances under twenty dollars are not included on the list, and multi-family and commercial properties are exempt from the process as the current Collection Services Agreement does not outline a procedure for collection from commercial and multi-family buildings. Once the final special assessment list is approved by Council, the Finance Department will send the list to the county and the amount will be placed on the property tax bill. If paid in full, the assessment will not remain on the property.

A summary of public comment is as follows: an inquiry regarding the source of the funds; opposition to addresses of individuals of unpaid bills being posted as a public document; an inquiry as to why multi-family and commercial buildings are not charged despite not paying the bill.

Heather Rowden, Finance & Administrative Services Director, presented the staff report. City staff seeks direction on a potential tax measure to update rates for the Business License Tax and to make technical changes to Section 5-1 and 5-2 of Chapter V of the Albany Municipal Code relating to the Business License Tax.

A summary of Council comment is as follows: Council may need to evaluate different types of businesses to determine a fair process for all; additional time may be necessary; cities cannot tax based on net rather than gross revenue; a suggestion to consider having two business sectors rather than multiple; a request for a model of a two-rate structure for consideration; it may be appropriate that the item be directed to the Economic Development Committee.

The City Council reached a consensus that more work is needed for this measure, and it is not ready to be placed on the ballot for this November 2022 election.




