## **RESOLUTION NO. 2022-100**

A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACT AMENDMENT #2 TO CONTRACT NO. C21-07 FOR ENGINEERING DESIGN SERVICES FOR THE 2023 SEWER REHABILITATION PROJECT WITH NUTE ENGINEERING UNDER THE CITY'S ANNUAL SEWER REHABILITATION PROGRAM (CIP NO. 32000)

WHEREAS, the City of Albany invests annually into the rehabilitation and renewal of aging sanitary sewer infrastructure and allocates budget through the Capital Improvement Plan to the Annual Sewer Rehabilitation Program (CIP No. 32000); and

WHEREAS, in 2014 the City entered into a Consent Decree agreement with the US EPA (United States Environmental Protection Agency) which requires rehabilitation of at least 5,706 linear feet of sewer main per year; and

WHEREAS, Nute Engineering has supported the City in accelerating design and construction of projects over the previous five years, including the achievement of the milestone goal of satisfying Consent Decree compliance requirements as of the end of fiscal year 2021; and


WHEREAS, staff intend for sewer rehabilitation under the 2023 Sanitary Sewer Rehabilitation Project to build a one-year buffer to 2014 EPA Consent Decree sewer rehabilitation rates; and

WHEREAS, Nute Engineering has a proven record of delivering design packages on-schedule and of a quality that demonstrates robust knowledge of the City's sewer system and standards; and

WHEREAS, staff requested and Nute Engineering provided a proposal for the noted additional engineering design services, which has been determined to be competitive with other firms offering this service.

NOW, THEREFORE, BE IT RESOLVED, that the Council authorizes the City Manager to execute Contract Amendment #2 to Contract No. C21-07 with Nute Engineering in the not-to-exceed amount of \$266,220.00 to add the 2023 Annual Sewer Rehabilitation Project using funds previously appropriated for the Annual Sewer Rehabilitation Program (CIP No. 32000).
