ORDINANCE NO. 2022-07

AN ORDINANCE OF THE ALBANY CITY COUNCIL ADDING SECTION 20.24.190 TO CHAPTER XX OF THE ALBANY MUNICIPAL CODE RELATED TO COMMUNITY BENEFITS OF THE SAN PABLO AVENUE SPECIFIC PLAN

WHEREAS, on December 6, 2004, the City Council of the City of Albany adopted Ordinance No. 04-09 establishing Chapter XX "Planning and Zoning" of the Albany Municipal Code; and

WHEREAS, Chapter XX established allowed uses, district regulations, development standards, review procedures, and parking requirements; and

WHEREAS, Government Code Section 65450 et seq. permits a city to adopt a specific plan for the implementation of the general plan for part of the area covered by the general plan; and

WHEREAS, the City Council held a public hearing on July 18, 2022 to consider the Specific Plan and related implementing documents; and

WHEREAS, on July 18, 2022, the City Council approved Resolution No. 2022-87, adopting amendments to the General Plan and an Addendum to the General Plan Environmental Impact Report for the San Pablo Avenue Specific Plan; and

WHEREAS, recitals and findings from Albany City Council Resolution No. 2022-87 are incorporated by reference; and

WHEREAS, on July 18, 2022, the City Council approved Resolution No. 2022-88, adopting Specific Plan, Design Guidelines and Objective Standards; and

WHEREAS, recitals and findings from Albany City Council Resolution No. 2022-88 are incorporated by reference; and

WHEREAS, the City desires to make certain related amendments to Chapter XX of the
Albany Municipal Code (the "Zoning Ordinance") to ensure consistency with the San Pablo
Avenue Specific Plan, and related to development standards applicable to the Specific Plan Area;
and
WHEREAS, the City has completed State-mandated environmental review procedures
for the project and has adopted a separate resolution for an Addendum to the General Plan
Environmental Impact Report, including Findings; and
WHEREAS, the Albany Planning and Zoning Commission conducted a public hearing
to consider the Community Benefits on June 22, 2022; and
WHEREAS, the Albany Planning and Zoning Commission adopted Planning & Zoning
Resolution No. 2022-04 recommending that the City Council adopt the Specific Plan, Design
Guidelines and Objective Standards, and Community Benefits; and

WHEREAS, the City published a public hearing notice in three public places and mailed notices on July 8, 2022 as required for a public hearing before the City Council; and

WHEREAS, the City Council held a public hearing on October 3, 2022 to consider the Specific Plan Community Benefits.

NOW, THEREFORE, THE ALBANY CITY COUNCIL ORDAINS AS FOLLOWS:

SECTION 1: CHAPTER XX OF THE ALBANY MUNICIPAL CODE, TITLED "PLANNING AND ZONING" IS HEREBY AMENDED AS FOLLOWS:

20.24.190: Community Benefits for San Pablo Avenue Specific Plan

The purpose of this section is to identify community amenities required for new residential projects in the San Pablo Avenue Specific Plan planning area to support equity, livability, sustainability and placemaking. These benefits may include but are not limited to below-market rate inclusionary housing units, sustainability measures, and open space. Benefits may be updated from time to time by ordinance of the City Council.

- A. Applicability: All residential projects, including mixed use projects, in the San Pablo Avenue Specific Plan planning area shall be required to provide community benefits. Projects in the northern node, as depicted in the San Pablo Avenue Specific Plan Zoning District & Overlays map (Figure 2-2), are required to provide additional benefits.
- B. Baseline Standards. Unless superseded by subsection C, below, all new residential projects in the San Pablo Avenue Specific Plan planning area are required to:
 - Increase the below-market rate unit requirement, pursuant to Section 20.40.030, from 15% to 20%, split between low and very-low income units, or fee in-lieu for ownership units pursuant to Section 20.40.030F.4; or
 - 2. Provide one amenity from subsection D (List A), below; or
 - 3. Provide two amenities from subsection E (List B), below.
- C. Northern Node Standards. Projects in the northern node that exceed 68 feet and/or 4.0 Floor Area Ration (FAR) are required to:
 - 1. Increase the below-market rate unit requirement, pursuant to Section 20.40.030, from 15% to 20%, split between low and very-low income units or fee in-lieu for ownership, pursuant to Section 20.40.030F.4; and
 - 2. Provide one amenity from subsection D (List A), below; or
 - 3. Provide two amenities from subsection E (List B), below.
- D. Community Benefits List A:
 - 1. Publicly-accessible open space (e.g., plazas) equal to at least 1,500 square feet or 10% of the lot area, whichever is greater.
 - Mid-block pedestrian connection on through-lots that extend from San Pablo Avenue to Adams Street or Kains Avenue.

3. Design and construction of site-appropriate bicycle, transit and pedestrian facilities in the adjacent public right-of-way (e.g., bus shelter, bike facility, crosswalk improvement).

E. Community Benefits List B:

- 1. Family-friendly housing, with at least 20% of units designed with 3+ bedrooms.
- 2. All electric design, defined as a building that has no natural gas or propane plumbing installed within the building, and that uses electricity as the source of energy for its space heating, water heating, cooking, and clothes drying appliances. This shall not be an eligible amenity that may be provided per Albany Municipal Code sections 20.24.190B.3 and C.3, should the City require an all electric design on residential projects in the future.
- 3. Installation of on-site photovoltaic or solar hot water panels, equivalent to powering at least 15% of building load.
- 4. Ground-floor commercial space with minimum depth of 50 feet for at least 50% of the width and at least 14 feet clear height inside the space.

SECTION 2: PUBLICATION AND EFFECTIVE DATE.

This ordinance shall be posted at three public places within the City of Albany and shall become effective thirty days after the date of its posting.

RESOLUTION NO. 2022-87

A RESOLUTION OF THE ALBANY CITY COUNCIL TO ADOPT AMENDMENTS TO THE GENERAL PLAN AND AN ADDENDUM TO THE GENERAL PLAN ENVIRONMENTAL IMPACT REPORT

WHEREAS, the California Government Code Section 65300 et. seq. requires every city and county in California to adopt a General Plan for its long-range development, and further, to periodically update that Plan to reflect current conditions and issues; and

WHEREAS, the Albany General Plan was adopted by the City Council on April, 18 2016, Resolution No. 2016-24; and

WHEREAS, through various actions in recent years, the State Legislature has declared that the availability of housing is of vital statewide importance and the governments have a responsibility to use the powers vested in them to facilitate the improvement and development of housing for all segments of the community; and

WHEREAS, Senate Bill 2 was part of a 15-bill housing package adopted in 2017 aimed at addressing the state's housing shortage and high housing costs by making funding available to all local governments in California for the preparation, adoption and implementation of plans that streamline housing approvals and accelerate housing production; and

WHEREAS, on May 6, 2019, the City Council approved Resolution 2019-29 authorizing staff to prepare an application to the State Department of Housing & Community Development for Senate Bill 2 grant funds, directing that the grant application language to be broad enough to include creation of a specific plan; and

WHEREAS, on September 3, 2019 the City Council reviewed the proposed scope of work and provided direction to incorporate the preparation of General Plan amendments, Zoning Code

priorities and a vision for the Specific Plan Area; and

WHEREAS, the General Plan amendments associated with the San Pablo Avenue Specific Plan (the "Specific Plan") apply within the 81 acres generally bound by Adams Street, Kains Avenue, and the City boundaries to the north and south (the "Specific Plan Area"); and WHEREAS, the Specific Plan identified changes to the regulatory framework of policies and actions needed to incentivize residential mixed-use development in the Specific Plan area; and WHEREAS, the City desires to make amendments to the General Plan to incorporate the policies and strategies identified in the Specific Plan; and WHEREAS, the General Plan Amendments are attached as Exhibit A and incorporated herein by reference, and are also on file with the Community Development Department; and WHEREAS, the Albany General Plan Environmental Impact Report, including Findings and a Mitigation Monitoring and Reporting Program was adopted by the City Council on April, 18 2016, Resolution No. 2016-23; and WHEREAS, the California Environmental Quality Act ("CEQA"), in conjunction with the State CEQA Guidelines, requires that certain projects be reviewed for environmental impacts; and WHEREAS, State CEQA Guidelines Section 15162 requires that when an EIR (Environmental Impact Report) has been certified for an adopted project, no subsequent EIR shall be prepared for that project unless the lead agency determines, on the basis of substantial evidence in light of the whole record, that one or more of the conditions described in CEQA Guidelines Section 15162 exists; and

WHEREAS, State CEQA Guidelines Section 15164(a) states that the lead agency shall prepare an Addendum to a previously certified EIR if some changes are necessary but none of the conditions described in CEQA Guidelines Section 15162, calling for the preparation of a subsequent EIR, have occurred; and

WHEREAS, the City retained Lexington Planning, W-Trans, and Rincon Consultants to study the potential environmental impacts caused by the Project; and

WHEREAS, in accordance with CEQA, the City prepared an Addendum to the General Plan EIR to analyze the environmental effects of the Project to determine if additional environmental review was required; and

WHEREAS, following an analysis of the proposed changes to land use policies and regulations, no new significant environmental impacts have been identified, no substantial increases in the severity of previously identified impacts were discovered, and the Project remains subject to all previously adopted mitigation measures, as applicable; and

WHEREAS, the Addendum to the EIR is dated July 2022 and is attached as Exhibit B and incorporated herein by reference, and is also on file with the Community Development Department; and

WHEREAS, the Albany Planning and Zoning Commission conducted a public hearing to consider the General Plan Amendments and Addendum to General Plan EIR on June 22, 2022; and

WHEREAS, the Albany Planning and Zoning Commission adopted Resolution 2022-03 recommending that the City Council adopt General Plan Amendments and an Addendum to General Plan EIR; and

WHEREAS, the City published a public hearing notice in three public places and mailed notices on July 8, 2022 as required for a public hearing before the City Council; and

WHEREAS, the City Council held a public hearing on July 18, 2022 to consider the General Plan Amendments and Addendum to General Plan EIR.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby:

<u>Section 1</u>. The Albany City Council does hereby make the necessary findings for the General Plan Amendments:

- 1. Reasons for Amendments. As described in the Specific Plan, a General Plan Amendment is required to amend the General Plan land use map, change land use designation on certain properties, revising development standards in land use policies, and indicating that the land within the Specific Plan boundary is governed by the Specific Plan.
- 2. Findings Supporting the Amendments. The General Plan amendments revise development standards to enable residential mixed-use development and pedestrian- and transit-oriented corridor envisioned General Plan. The Specific Plan allows for a range of housing types and densities, creates a transition between higher density buildings along the San Pablo Avenue corridor and lower density neighborhoods to east and west. Design guidelines and standards aim to provide more consistency in the character of the district and façade design of existing and future buildings. The land use plan also expands options for affordable housing and commercial retail. The Specific Plan identifies financing mechanisms, infrastructure needs, and implementation programs to bring private and public projects to fruition. The Specific Plan also supports public spaces and plazas that support gathering in nodes and contribute to the identity of the neighborhood. In these ways, the Specific Plan is consistent with the General Plan, including the following General Plan policies:

 Policy LU-1.1: New Housing Opportunities. Create opportunities to meet the housing needs of current and future Albany residents by zoning land for a variety of housing types, particularly on underutilized commercial properties. To the extent possible, new development throughout the city should be leveraged to create onsite and off-site opportunities for housing serving very low-, low-, and moderate-income households.

- Policy LU-1.3: Business Districts. Maintain and enhance San Pablo and Solano
 Avenues as Albany's principal commercial streets. Encourage a vibrant mix of ground
 floor retail and service uses that meet the needs of Albany residents, enhance the local
 tax base, provide job opportunities, and provide a safe, walkable environment.
- Policy LU-1.8: Transit-Oriented Development. Encourage land use patterns that support transit use, including additional mixed-use (commercial and higher-density residential) development along the San Pablo and Solano Avenue corridors.
- Policy LU-1.9: Income Diversity. Recognize economic and income diversity as one of Albany's greatest strengths. Ensure that future land use decisions contribute to this diversity by creating housing and employment opportunities for persons of all incomes and backgrounds.
- Policy LU-2.2: Mixed Density Areas. In areas designated for high and medium density
 residential uses, ensure that new development is designed to minimize sharp contrasts
 in height, prevent the loss of sunlight and privacy for adjacent homes, and provide
 buffering and screening from nearby lower density uses.
- Policy LU-2.3: Design Guidelines. Maintain residential design guidelines and design review procedures that promote the compatibility of residential alterations and additions with existing homes and that strive to reduce impacts on neighboring

properties. The guidelines should be used to encourage high-quality, visually distinctive architecture, and the use of durable, attractive construction materials.

- Policy LU-2.8: Kains Avenue and Adams Street. Maintain Kains Avenue and Adams Street as predominantly residential streets. Land use regulations should limit the encroachment of commercial uses onto parcels that are currently developed with housing. Residential uses along these streets and in adjacent areas should be protected from the potential adverse impacts of commercial uses through special setback requirements. The use of these two streets for primary access to non-residential uses shall be discouraged or prohibited as appropriate.
- Policy LU-3.1: Mixed-Use Development. Encourage mixed-use development combining residential uses above ground floor commercial uses along the San Pablo and Solano Avenue corridors. The City's zoning regulations should continue to provide floor area ratio (FAR) incentives for projects that include multi-family residential uses on the upper stories. State density bonus provisions for affordable housing may be used to allow floor area bonuses above and beyond those provided by the City of Albany, up to a maximum FAR of 3.0 for parcels on San Pablo Avenue and 2.0 for parcels on Solano Avenue. [NOTE: Amended per Exhibit A]
- Policy LU-3.2: San Pablo Avenue. Continue to foster the transformation of San Pablo
 Avenue from an auto- oriented commercial strip to a pedestrian- and transit-oriented
 retail boulevard. San Pablo Avenue should be a source of community pride, with
 distinctive buildings, an attractive streetscape, and a diverse mix of uses.
- Policy LU-3.3: Solano Avenue. Enhance the pattern of tightly clustered retail storefronts, active ground floor uses, and specialty shopping, dining, and personal services along the Solano Avenue corridor. Any future infill development on Solano Avenue should maintain and enhance this pattern.

- Policy LU-3.4: Solano/San Pablo. Enhance the intersection of Solano and San Pablo
 Avenues as the "center" of Albany and a major activity node. Land use regulations and
 design guidelines should reinforce the identity of this area as a hub of pedestrian traffic,
 distinctive architecture, and active ground floor uses.
- Policy LU-3.8: Buffering. Require buffering of residential uses, particularly along Kains Avenue, Adams Street, and the perpendicular side streets that intersect Solano Avenue, from the potentially adverse impacts created by nearby commercial activities. This should include special setback and daylight plane regulations to be applied where commercial zones abut lower density zones. It may also include special use, design, and noise standards. [NOTE: Amended per Exhibit A]
- Policy LU-3.12: Lot Consolidation. Support the consolidation of underutilized parcels
 on the Solano and San Pablo corridors to create sites that are more viable for future
 mixed-use development, including on-site parking. Development on larger sites should
 be designed to respect the fine-grained character of nearby properties, and should be
 articulated into multiple smaller storefronts rather than long, unbroken facades.
- Policy LU-3.15: Northern Gateway. Ensure that any future development on the Albany Bowl site, and surrounding sites along San Pablo Avenue north of Clay Street, reflects the importance of this area and its function as a northern gateway to the City.
- Action LU-3.B: Major Activity Nodes. Develop land use and design regulations that reinforce key areas along San Pablo and Solano Avenues as major activity nodes, particularly around the intersection of these two streets.
- Subsequent planning studies should identify the desired character, activities, and development standards at the San Pablo-Solano node, the Northern Gateway node, and

other nodes that may be identified in the future. The purpose of a node is to intensify pedestrian-oriented retail, commercial and mixed-use activities at key locations. The City will work with property owners and neighbors in these areas to explore incentives, facilitate lot consolidation, and create more viable development opportunities.

- Action LU-3.D: San Pablo Avenue Design Guidelines. Update the San Pablo Avenue Design Guidelines. In addition to providing direction on building scale, commercial facades, landscaping, and public improvements, the guidelines should consider the segmentation of the corridor into "districts" which are different in their function and character. If such districts are identified, zoning code amendments should be considered to reinforce the desired character.
- 3. Relationship of the Amendment to Applicable Plan. The amendment of the General Plan text and land use map are necessary to implement the goals of the Specific Plan and the policies of General Plan.

Section 2. The Albany City Council hereby makes the following necessary findings and determinations regarding the Project, based on the following findings and considering the staff report, the Addendum and the whole of the record related to the Project:

- 1. Pursuant to CEQA and the CEQA Guidelines, the City Council finds, on the basis of substantial evidence set forth in the record, including but not limited to, the General EIR, the Addendum, and all related information presented to the City Council, that the environmental effects of the proposed Project were sufficiently analyzed and that an Addendum to the EIR is the appropriate environmental document for the Project.
- 2. The City Council further finds that none of the circumstances described in the CEQA Guidelines requiring preparation of a subsequent or supplemental EIR exist, as described in Exhibit B.

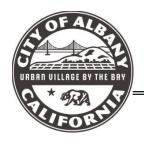

3. The City Council finds that the Addendum contains a complete, objective, and accurate reporting of the environmental impacts associated with the Project and reflects the independent judgment and analysis of the Council.

BE IT FURTHER RESOLVED, that the Albany City Council adopts the proposed Amendments to the Albany General Plan (Exhibit A) and Addendum to the General Plan EIR (Exhibit B).

A RESOLUTION OF THE ALBANY CITY COUNCIL TO ADOPT THE PROPOSED SAN PABLO AVENUE SPECIFIC PLAN AND THE DESIGN GUIDELINES AND OBJECTIVE STANDARDS

WHEREAS, Government Code Section 65450 et seq. permits a city to adopt a specific plan for the implementation of the general plan for part of the area covered by the general plan; and

WHEREAS, on July 18, 2022, the City Council approved Resolution 2022-87, adopting Amendments to the General Plan and an Addendum to the General Plan Environmental Impact Report for the San Pablo Avenue Specific Plan; and

WHEREAS, recitals and findings from Albany City Council Resolution No. 2022-87 are incorporated by reference; and

WHEREAS, in conjunction with the Specific Plan, the City prepared Design Guidelines and Objective Standards to replace the 1993 San Pablo Avenue Design Guidelines; and

WHEREAS, in conjunction with the Specific Plan, the City prepared objective Community Benefits which are required for all new development in the Specific Plan Area; and

WHEREAS, the Specific Plan establishes a regulatory framework for policies and actions to incentivize residential mixed-use development in the Specific Plan area; and

WHEREAS, the Specific Plan includes goals and policies related to land use, housing, transportation, infrastructure and design to fulfill the vision for the Specific Plan Area and establishes uses and development standards for the Specific Plan Area; and

WHEREAS, the Specific Plan includes text and diagrams specifying the distribution, location, and extent of the uses of land within the area covered by the plan, as well as the location, and extent and intensity of major components of infrastructure and other essential facilities located within the Specific Plan Area; and

WHEREAS, the Specific Plan, Zoning Ordinance, Design Guidelines and Objective Standards, and Community Benefits identify standards and criteria by which development will proceed; and

WHEREAS, the Specific Plan is consistent with the policies, goals and vision set out in the General Plan; and

WHEREAS, the Specific Plan incorporates all necessary components to comply with current state law; and

WHEREAS, a Draft Specific Plan was published for public review and comment on June 10, 2022 and the Draft Specific Plan is incorporated into this resolution by reference as Exhibit A; and

WHEREAS, the City has completed State-mandated environmental review procedures for the project and has adopted a separate resolution for an Addendum to the General Plan Environmental Impact Report, including Findings; and

WHEREAS, the Albany Planning and Zoning Commission conducted a public hearing to consider the Specific Plan, Design Guidelines and Objective Standards, and Community Benefits on June 22, 2022; and

WHEREAS, the Albany Planning and Zoning Commission adopted Resolution 2022-04 recommending that the City Council adopt the Specific Plan, Design Guidelines and Objective Standards, and Community Benefits; and

WHEREAS, the City published a public hearing notice in three public places and mailed notices on July 8, 2022 as required for a public hearing before the City Council; and

WHEREAS, the City Council held a public hearing on July 18, 2022 to consider the General Plan Amendments and Addendum to General Plan EIR.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby makes the necessary findings for the Specific Plan, Design Guidelines and Objective Standards:

- 1. The proposed Specific Plan establishes appropriate goals, policies, and programs to address land use and housing withing the Specific Plan Area.
- 2. The proposed Specific Plan has been prepared in conformity with the provisions of the State Government Code for Specific Plans.
- 3. The proposed adoption of the San Pablo Avenue Specific Plan is consistent with the Albany General Plan. As envisioned by the General Plan, the City of Albany is proposing the San Pablo Avenue Specific Plan to transform San Pablo Avenue from an auto-oriented commercial strip to a pedestrian- and transit-oriented boulevard, with a diverse mix of uses (General Plan Policy LU-3.2: San Pablo Avenue). This objective was established by the City of Albany in 2016 when it adopted the General Plan. The General Plan articulates this vision, and the Specific Plan establishes a strategy, set of policies and programs, and implementation actions, including zoning amendments, for achieving this vision.

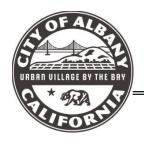
