

1 **RESOLUTION NO. 2022-112**

2 **A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING**
3 **THE CITY MANAGER TO EXECUTE AMENDMENT #1 TO**
4 **CONTRACT NO. C22-19 WITH CAP ENGINEERING**

5 **WHEREAS**, the City of Albany’s storm drain system consists of approximately 12
6 miles of storm drain pipelines which convey collected stormwater into local waterways; and
7

8 **WHEREAS**, discharges into local waterways are regulated under the Federal Clean
9 Water Act; and
10

11 **WHEREAS**, Albany complies with the requirements of the Municipal Regional
12 Stormwater Permit (MRP) Order R2-2022-0018, NPDES (National Pollutant Discharge
13 Elimination System) Permit No. CAS612008, adopted July 1, 2022, referred to as MRP 3.0;

16 **WHEREAS**, MRP 3.0 requires permittees to conduct inspections of the commercial
17 and industrial activities in its jurisdiction that may be sources of stormwater pollutants,
18 including industrial facilities, auto-related businesses, and restaurants; and
19

20 **WHEREAS**, in March 2022, the City of Albany awarded Contract No. C22-19 to CAP
21 Engineering to provide stormwater inspection support services for the City for a period of
22 one year; and
23

24 **WHEREAS**, CAP Engineering performed business outreach and successfully
25 completed 43 stormwater inspections on behalf of the City for permit compliance; and

1 WHEREAS, CAP Engineering has performed well with the existing contract services,
2 demonstrated responsiveness to City staff, and retained competitive pricing as compared with
3 other vendors offering similar services.

5 NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby
6 authorizes the City Manager to execute Amendment #1 to Contract No. C22-19 with CAP
7 Engineering, extending the term of the contract for three years and two months through
8 September 2025, and increasing the contract amount by \$96,900, using funds previously
9 appropriated as part of the Public Works Operating Budget.
