Contract No. C22-14 Closeout and Filing of Notice of Completion

SUMMARY

Construction of Phase 5 and Phase 6 of the Sidewalk Rehabilitation Program (Project), Contract No. C22-14, is complete. Staff recommends that the Council authorize the City Manager to approve the final contract change order, to accept the improvements, and file the Notice of Completion.

STAFF RECOMMENDATION

That Council adopt Resolution No. 2022-127, authorizing the City Manager to:

- 1. Approve Contract Change Order #3 (CCO#3); and
- 2. Accept the improvements completed in Contract No. C22-14; and
- 3. File the Notice of Completion with the County Recorder's Office.

BACKGROUND

As per California state law (SHC §5600 et seq.), sidewalk repair and maintenance responsibilities fall to the adjacent property owner. For a variety of reasons, the rate of repair of sidewalks in Albany has historically been low.

In June 2016, Council adopted a new City Sidewalk Repair Policy and placed a tax measure on the ballot to fund City-centralized sidewalk repair and replacement. Albany voters approved this tax measure, Measure P1, in the November 2016 General Election. The parcel tax is an effort to ensure that the needed funds are available for repair and that conditions of a sidewalk are not dependent on individual owner's resources and motivation to ensure that the City sidewalk network remains in good condition with safe passage for all. Revenues from this tax fund the City's Annual Sidewalk Rehabilitation Program (CIP No. 22000), which is planned as part of the City's Capital Improvement Plan (CIP). Albany's CIP was most recently adopted in November 2020 (Resolution No. 2020-108) with a status report presented to the City Council in May 2022.

In April 2021, Beneficial Designs, a firm specializing in evaluating accessibility issues, performed a comprehensive sidewalk survey throughout the City. The survey results were used to compile a geographic information system (GIS) database, allowing for a data-driven process to scope future

repair locations. Using this GIS data, City staff identified the most hazardous and severe issues in the City. Staff then prepared a modified repair prioritization criteria for recommendation. The Transportation Commission approved the modification of the prioritization criteria and the list of locations for Phase 5 repairs in January 2022. The Commission subsequently approved the Phase 6 scope at their July 2022 meeting.

On June 21, 2022, the Council authorized the award of Contract No. C22-14 to MCE Corporation (MCE) for construction of the Phase 5 Project for the not-to-exceed amount of \$249,450 (Resolution No. 2022-67).

On September 6, 2022, the Council authorized Contract Change Order #1 for construction of Phase 6 for the not-to-exceed amount of \$111,287.50 (Resolution No. 2022-96).

On September 28, 2022, the City Manager authorized Contract Change Order #2 for various contract changes regarding stump grinding and curb and asphalt repair during Phase 5 for the not-to-exceed amount of \$22,598.

DISCUSSION

MCE started construction on the Phase 5 project in July 2022, with the Phase 6 work commencing in October 2022, and has since completed the full scope of the Project. The completed work includes:

- Rehabilitation of approximately 12,700 square feet of sidewalk;
- Removal of approximately 760 square feet of sidewalk concrete to expand permeable surfaces for tree basins and planter strips;
- Rehabilitation of approximately 110 linear feet of curb and 20 linear feet of gutter; and
- Rehabilitation of approximately 360 square feet of asphalt.

The project ultimately included sidewalk rehabilitation at a total of **83 locations**: 76 critical repair locations, six special access needs issue locations, and 1494 Solano Avenue. The 1494 Solano work was filling in a former tree basin to ensure an ADA-compliant (American Disability Act-compliant) path of travel width and utilized funds from the Public Works operating budget.

Included in this report is a final contract change order quantifying all necessary project adjustments. Staff is requesting the Council to authorize the City Manager to approve CCO#3. The change order documents the terms for closing out the project including settlement of outstanding issues, claims, and request for equitable adjustment, compensates MCE for extra work items that were not in the original contract documents, and details the final quantities.

Contract No. C22-14 was awarded in the amount of \$249,450 with previous change orders totaling an additional \$133,885.50. CCO#3 is a reduction of \$31,074.38 to reflect final quantities due mostly to a higher design estimate for Phase 5 repair quantities. The revised, final contract price is \$352,261.13. Refer to Attachment 3 (Statement of Final Accounting) for further detail.

The Project is now complete and a Notice of Completion is required to be filed with the County Recorder's Office.

SUSTAINABILITY

The Annual Sidewalk Rehabilitation program will improve walkability which is one of the City's sustainability goals. Sidewalk improvements afford greater mobility by disabled persons, strollers, and able-bodied persons in general. This promotes non-motorized travel, thereby reducing air emissions. The project also supports goals adopted in the Active Transportation Plan.

FINANCIAL SUMMARY

As noted previously, the Project is part of the City's Annual Sidewalk Rehabilitation Program (CIP No. 22000). The budget for this program was approved by Council as part of the City's Capital Improvement Plan in November 2020 (Resolution No. 2020-108).

The following table details Project expenditures and changes:

The project was predominantly funded via the Measure P1 Sidewalk Parcel Tax.

The contractor also performed approximately \$15,000 of work included in the above table on adjacent repairs that were funded via the Public Works Operating Budget and the Annual Street Rehabilitation Program (CIP No. 21000) budgets.

13	property are required to maintain adjacent public sidewalks in a safe condition; and

16	the purposes of publicly funding repairs to the City sidewalks; and

18	WHEREAS, in November 2020, the City Council approved Resolution No. 2020-108,
19	adopting the FY2019/20 – 2023/24 Capital Improvement Plan and appropriating funds for the
20	first three fiscal years of the Plan, including funding from the Sidewalk Parcel Tax Fund (1305)
21	for the Annual Sidewalk Rehabilitation Program (CIP No. 22000); and

23	WHEREAS, on June 21, 2022, the City Council awarded Contract No. C22-14 to MCE
24	Corporation for construction of Phase 5 of the Sidewalk Rehabilitation Program; and

26	WHEREAS, on September 6, 2022, the City Council authorized Contract Change Order
27	#1 for construction of Phase 6 of the Sidewalk Rehabilitation Program; and

1	WHEREAS, on September 28, 2022, the City Manager authorized Contract Change
2	Order #2 for various contract changes regarding stump grinding and curb and asphalt repair

5	WHEREAS, the final Contract Change Order (#3) reduces the contract amount by
6	\$31,074.38, resulting in a revised, final contract amount of \$352,261.13; and
