**A RESOLUTION OF THE ALBANY CITY COUNCIL APPROVING
CONTRACT NO. C22-72 WITH ENVIRONMENTAL SCIENCE ASSOCIATES
FOR PROJECT MANAGEMENT SERVICES IN SUPPORT OF THE CITY'S
ANNUAL SEWER REHABILITATION PROGRAM (CIP NO. 32000)**

WHEREAS, the City of Albany operates the Albany Bulb, a covered former landfill that extends into the San Francisco Bay, as a public space; and

WHEREAS, the San Francisco Bay Regional Water Quality Control Board regulates the potential discharges of contaminants that may affect the water quality of the San Francisco Bay; and

WHEREAS, on October 12, 2022, the Water Board adopted Order No. R2-2022-0031 amending Waste Discharge Requirements for bayside landfills that require landfill operators to prepare and submit a Long-Term Flood Protection Plan within 270 days of the order date, consisting of a vulnerability assessment and adaptation plan to address the effects of sea level rise due to climate change; and

WHEREAS, Environmental Science Associates (ESA) has previously prepared a coastal vulnerability assessment for Albany Bulb as part of past condition assessment and management planning efforts, and has been found to provide quality work at a reasonable cost; and

WHEREAS, with consideration for the deadlines set by the Water Board, staff requested and ESA provided a reasonable proposal to build upon their previous work to prepare a Long-Term Flood Protection Plan meeting the requirements prescribed by the Water Board.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorizes the City Manager to award Contract No. C22-72 to ESA in the amount of \$99,943 to assist the City in preparing a Long-Term Flood Protection Plan, and appropriates \$115,000 from the General Fund to fund the project, including a reasonable contingency.
