ALBANY STREET TREE PLANTING APPLICATION

In an effort to enhance Albany's residential neighborhoods, the City created this program, in which property owners may apply for a street tree to be planted in the public right-of-way adjacent to their property. The property owner agrees to water the tree according to the instructions provided by the City. The tree is public property and is pruned only through City-approved permit or by an agent of the City.



The Benefits of Trees

Trees are good for communities in many ways. Trees beautify neighborhoods and therefore increase property values. They promote energy savings by shading pavement and reducing wind. Trees reduce noise pollution, create privacy, furnish shelter and food for birds, supply fresh air, have a calming effect on traffic and offset the impacts of car exhaust and other pollutants. Trees also sequester carbon, help retain rainwater, and slow storm runoff. In these and many other ways, they have a direct effect on our well-being.

Applying for a street tree is easy!

Choose a species from the ACCEPTED STREET TREE LIST on our web page and submit your application.

Species and location will be reviewed by the Urban Forester and may be subject to change due to availability and/or site restrictions.

Trees are generally planted from October through April each year, or as weather permits.
