1 **ORDINANCE NO. 2023-02** 2 AN ORDINANCE OF THE ALBANY CITY COUNCIL AMENDING 3 SECTIONS OF THE ALBANY MUNICIPAL CODE RELATED TO 4 THE PARKS RECREATION & OPEN SPACE COMMISSION AND THE TRANSPORTATION COMMISSION REGARDING STUDENT 5 AND STUDENT-AFFILIATED APPOINTMENTS 6 7 WHEREAS, the City Council established an ad hoc committee to review the policies 8 9 associated with the structure for appointing school affiliated nominees to City Advisory Bodies; 10 and 11 12 WHEREAS, engaging youth in local government is an ongoing priority of the City Council; and 13 14 WHEREAS, the City Council has directed that updates be made to the composition of 15 advisory bodies to the City Council to further the goal of engaging youth in local government. 16 17 18 NOW, THEREFORE, THE ALBANY CITY COUNCIL ORDAINS AS 19 **FOLLOWS:** 20 SECTION 1: CHAPTER II OF THE ALBANY MUNICIPAL CODE, SECTION 21 2-17.1 (b), "PARK, RECREATION AND OPEN SPACE COMMISSION" IS HEREBY 22 **AMENDED AS FOLLOWS:** 23 24 2-17.1 Established; Composition; Appointment; Term. 25 There is hereby established within the City a commission to be known as the "Parks, 26 Recreation and Open Space Commission of the City". The Parks, Recreation and Open Space Commission of the City shall consist of seven (7) members, as follows: 27 Five (5) members of such Commission shall be appointed by Councilmembers; 28 each Councilmember shall appoint one (1) member to the Commission.

2	<u>c.</u> The Commission shall have a Chairperson and a Vice Chairperson who shall be members of the Commission;
4 5	d. The Chairperson and Vice Chairperson shall rotate per the advisory body rules and procedures; and
6 7	e. The City Manager shall designate a staff liaison to the Commission.
8 9	2-20.4 Meetings, Generally.
10 11	c. Quorum. Three Four (4) voting members shall constitute a quorum.
12	SECTION 3: PUBLICATION AND EFFECTIVE DATE. This ordinance shall be posted at three public places within the City of Albany and shall
13 14	become effective thirty days after the date of its posting.
