2 **A RESOLUTION OF THE ALBANY CITY COUNCIL**
3 **CONFIRMING THE ASSESSMENT AND ORDERING THE LEVY FOR**
4 **THE LANDSCAPING AND LIGHTING ASSESSMENT**
5 **DISTRICT NO. 1988-1 FOR FISCAL YEAR 2021/22**

6 The City Council (the “Council”) of the City of Albany (the “City”) does resolve as follows:

8 **WHEREAS**, the Council previously completed its proceedings in accordance with
9 and pursuant to the Landscaping and Lighting Act of 1972, Part 2, Division 15 of the
10 California Streets and Highways Code (commencing with Section 22500) (the “Act”) to
11 establish the City’s Landscaping and Lighting Assessment District No. 1988-1 (the
12 “Assessment District”); and

13 **WHEREAS**, the City has retained NBS for the purpose of assisting with the annual
14 levy of the Assessment District, and the preparation and filing of an Annual Report; and

16 **WHEREAS**, the City has, by previous resolution, declared its intention to hold a
17 Public Hearing concerning the levy and collection of assessments within the Assessment
18 District; and

20 **WHEREAS**, a Public Hearing has been held and concluded and notice thereof was
21 duly given in accordance with Section 22626 of the Act; and

23 **WHEREAS**, at the time and place specified in the Resolution of Intention the City
24 conducted such hearing and considered all objections to the assessment.


25 **NOW, THEREFORE BE IT RESOLVED, DETERMINED, AND ORDERED**
26 **BY THE COUNCIL, AS FOLLOWS:**

28 **1. Confirmation of Assessment and Diagram:** The Council hereby confirms the
29 assessment and the diagram as is described in full detail in the Annual Report on file
with the Clerk.
