# 2. STUDY SESSION

**2-1.** Albany Hill Eucalyptus Project (CIP No. 41015) – Development of the Albany Hill Forest Management and Habitat Restoration Plan

Staff Recommendation: That the Council:

- 1. Receive a presentation regarding the Albany Hill Eucalyptus Project
- 2. Provide feedback and direction on the Project

Public Works Director Mark Hurley announced the kickoff of the Albany Hill Forest Management and Habitat Restoration Plan (Plan).

Natural Areas Coordinator Margot Cunningham presented the staff report. In 2020, staff noticed eucalyptus trees on Albany Hill turning brown. The City partnered with experts and other government agencies to assess the trees, fire hazards, and the monarch habitat. Reports revealed the poor health of most of the eucalyptus trees. Next, the City created the Albany Hill Eucalyptus Project (Project), sought funding, and selected a consultant team to develop a comprehensive plan for the eucalyptus trees and native plants and wildlife. The project team includes City staff, Restoration Design Group, Nomad Ecology, and Creekside Science. The Albany Hill Users Survey has received more than 500 responses and will be open until October 31, 2023. Most of the survey respondents support the Project and live in Albany and El Cerrito.


Erik Stromberg, Restoration Design Group, advised that the Plan focuses on City property located at the top of Albany Hill. Goals consist of minimizing hazards from falling trees and fire risk, providing monarch butterfly habitat, supplementing native plant communities, and creating self-sustaining ecosystems with low fire hazards and minimal maintenance requirements. The scope of the project is to distill existing information into an initial proposal, incorporate additional expert perspectives, educate and receive feedback from the public, verify that the Plan is consistent with the will of the public, and produce construction and maintenance plans. Project considerations include fire hazard, monarch habitat, habitat restoration, phasing, property ownership, and views from and of Albany Hill.

A summary of public comment is as follows: concerns about a monoculture of oak woodland and the spread of oxalis; questions regarding the number of eucalyptus trees to be removed and consideration of the theory that trees adapt to climate change; suggestions to build additional trails, remove poison oak, , and leave some fallen trees for birds or install nest boxes.

Mr. Stromberg indicated the number of eucalyptus trees to be removed has not been determined, but some will probably remain. Climate change is occurring faster than the existing trees can adapt to it. Poison oak grows well under eucalyptus trees and will remain on Albany Hill after the Plan is complete.

A summary of Council comment is as follows: managing fire risk goes hand-in-hand with maintaining ecological integrity; discussions of habitat restoration and ecology need to include indigenous and traditional knowledge of the area; appreciation for staff's outreach to indigenous cultures; a lower fire spread rate for the area from the crown to the residences on Taft Street would be beneficial; poison oak has a role on Albany Hill; a preference for planting native tree species rather than eucalyptus trees.

City Manager Nicole Almaguer reported a Town Hall regarding the Albany Twin closure will be held on October 5, 2023 at the Community Center. Albany residents can register for the event at stopwaste.org/hhw-albany. Albany's 115<sup>th</sup> Anniversary of Incorporation will be celebrated on September 20, 2023 with a concert in Memorial Park. Albany Fire and Police Departments will roll out the Leave Narcan Behind Program in September 2023 with training and supplies of Narcan. Requests for Narcan can be emailed to naloxone@albanyca.org. A City Streetlighting Workshop is scheduled for September 19, 2023 at the Senior Center. Albany Local Week is September 18-24, 2023 (albanyca.org/albanylocalweek). 

# **10-1.** Amendment to Council Reorganization Policy

Council Member Jordan & Vice Mayor Miki Recommendation: That the Council direct staff to prepare a resolution approving an amendment to the Council reorganization policy to preclude a Council Member who will be termed out in one year from being appointed Vice Mayor for the next year

Council Member Jordan presented the memorandum. One of the purposes of serving as Vice Mayor is to learn the role and duties of Mayor. The current reorganization policy allows a Council Member to serve as Vice Mayor when the Council Member will be termed out the following year. The proposed revisions to the reorganization policy would preclude this scenario from occurring.

Vice Mayor Miki proposed reordering and reformatting the reorganization policy to facilitate comprehension of its terms.

A summary of public comment is as follows: a suggestion to add a clause allowing the Mayor and Vice Mayor to serve a second year under special circumstances; opposition to the proposed revisions.

A summary of Council comment is as follows: as currently written, the reorganization policy orders the queue for Vice Mayor and Mayor based on the number of votes received in the election; a suggestion to replace "termed out" with "term limited" in subsections (d)(5) and (e); a clause for special circumstances is covered in subsection (d)(6); the proposal is intended to reflect the will of the voters and allow all Council Members to serve as Mayor and Vice Mayor; the proposal is justified until the Mayor is directly elected.

Moved by Council Member Jordan, seconded by Council Member Hansen-Romero, to direct staff to prepare a resolution approving the proposed amendments to Section L-1 of the Council reorganization policy with "term limited" replacing "termed out" in subsections (d)(5) and (e).

City Attorney Mala Subramanian presented the staff report. Amendment No. 4 to the Employment Agreement for City Manager Services proposes a base salary of \$266,279 effective July 1, 2023. The Council requested the amendment after a performance evaluation.

A summary of public comment is as follows: a request for the City Manager's original salary.

City Attorney Subramanian advised that the City Manager's base salary under the original 2018 agreement was \$178,236..

A summary of Council comment is as follows: the City Manager position is not paid hourly, and the City Manager works more than 40 hours per week; the City is fortunate to have City Manager Almaguer,; the City Manager's compensation is well below that paid in comparable cities; City Manager Almaguer has served the City well for many years, anticipates the City's needs, and truly cares about the community; positions have not been lost to fund a compensation increase; a compensation increase communicates the Council's evaluation of the City Manager's performance.



Council Member Jordan encouraged residents to eliminate standing water from their property because mosquitos breed in it.
