13	Rehabilitation Program (CIP No. 35000); and

15	WHEREAS, the 2023 Storm Drain Repair Project consists of repair of cross drains, drain
16	inlets, concrete, and storm drain pipeline replacement at 18 locations around the City; and

18	WHEREAS, on June 20, 2023, the City Council authorized staff to advertise the Notice
19	Inviting Bids for the 2023 Storm Drain Repair Project; and
20	
21	WHEREAS, on August 29, 2023, the City received and opened seven (7) bids for the
22	above-mentioned project; and

24	WHEREAS, GradeTech Inc. is the lowest responsible and responsive bidder for the
25	construction of the 2023 Storm Drain Repair Project.
26	NOW THEDEFORE DE IT DESOI VED that the Albany City Council outhorize the
27	NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council authorize the
28	City Manager to award Contract No. C23-39 to GradeTech Inc. to construct the 2023 Storm

Drain Repair Project for the not-to-exceed amount of \$135,660.00 and execute Contract No.

C23-66 with CAP Engineering to provide construction management services for the not-to-exceed amount of \$28,525.00, using funds previously appropriated as part of the Annual Storm Drain Rehabilitation Program (CIP No. 35000).
