RESOLUTION NO. 2023-68

A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO APPROVE FINAL CONTRACT CHANGE ORDER #10 TO CONTRACT NO. C21-49, ACCEPT THE IMPROVEMENTS COMPLETED IN CONTRACT NO. C21-49, AND AUTHORIZING CITY MANAGER TO FILE THE NOTICE OF COMPLETION

WHEREAS, the City of Albany maintains 30 miles of public streets and roadways, with an overall pavement condition index (PCI) of 56 as calculated by the Metropolitan Transportation Commission (MTC); and

WHEREAS, the Annual Street Rehabilitation Program (CIP No. 21000) is included in the Capital Improvement Plan adopted in November 2020, and reflects the City's commitment to ongoing investment into improving and maintaining City street conditions, including the Citywide PCI, on an annual basis; and

WHEREAS, on December 20, 2021 the City Council authorized the award for the Washington Avenue Rehabilitation Project – Phase 2 to McGuire and Hester for pavement rehabilitation and other improvements within the City (Resolution No. 2021-121); and

WHEREAS, City Council subsequently approved the additional limits under the Annual Street Rehabilitation Program (CIP No. 21000) to Contract No. C21-49, including the Marin Avenue Paving and Curb Ramp Rehabilitation Project – Phase 1 (Resolution No. 2022-68) and the extension of paving limits to include Masonic Avenue between Marin Avenue and Solano Avenue (Resolution No. 2023-26); and

WHEREAS, City Council approved the addition of speed humps under the Traffic Calming Citywide Project (CIP No. 25001) to Contract No. C21-49 on Masonic Avenue and Key Route Blvd (Resolution No. 2023-26); and

WHEREAS, City Council approved the addition of speed humps under the Traffic Calming Citywide Project (CIP No. 25001) to Contract No. C21-49 on Masonic Avenue and Key Route Blvd (Resolution No. 2023-26); and

WHEREAS, staff recognized that inter-project coordination and schedules allowed for cost savings by removal of temporary striping from Contract No. C21-65 for the Masonic Intersections (Ohlone Trail Safety Improvements) Project (CIP No. 25007) and completion of permanent striping under Contract No. C21-49; and

WHEREAS, a final contract change order is necessary to tabulate adjustments to final quantities and for extra work, including additional paving quantities for Masonic Avenue between Marin Avenue and Solano Avenue, additional curb & gutter drainage improvements, minor inter-project coordination work, sidewalk repairs, and expediting schedule delays and impacts during a historically wet weather season; and

WHEREAS, Contract Change Order #10 to Contract No. C21-49 increases the contract amount by \$447,489.08 for a final contract total of \$3,224,394.37; and

WHEREAS, there is sufficient budget remaining in the appropriated budget for the Annual Street Rehabilitation Program (CIP No. 21000) and Masonic Intersections Project (CIP No. 25007) for this change order, and no additional budget appropriations are recommended at this time.

NOW, THEREFORE, BE IT RESOLVED, that that the Albany City Council hereby authorizes the City Manager to approve final Contract Change Order #10 to Contract No. C21-49, accept the improvements completed in Contract No. C21-49, and authorizes City Manager to file the Notice of Completion.
