Environmental Review

These General Plan and Zoning Ordinance amendments are within the scope of the General Plan Environmental Impact Report (EIR) that was certified in April 2016. The EIR contemplated revisions to parking standards over time, including those that resulted in Measure D, which modified minimum parking requirements. Moreover, parking is no longer an impact topic under the California Environmental Quality Act (CEQA).

Additionally, on February 21, 2023, the City Council adopted an Addendum to the General Plan EIR to analyze potential impacts of the 2023-2031 Housing Element. This evaluation included implementation of Housing Element Program 4.E, described herein, to revise minimum and maximum parking requirements.
