

5. CITY MANAGER REPORT

City Manager Nicole Almaguer reported Avenu mailed notices for business license renewals the week of December 15, 2023, and business licenses can be renewed via an online portal beginning January 2, 2024. Information regarding the portal is available at albanyca.org/business/business-licenses. On December 13, 2023, the Albany Police Department and Albany Police Officers Association participated in Target's Heroes and Helpers program. An interactive kiosk honoring Dr. Martin Luther King, Jr., will be located at the Community Center from January 3-16, 2024, and provide opportunities to volunteer with community organizations. Registration for the Recreation and Community Services Department's winter/spring programs is open; the Activity Guide is available at albanyca.org/recreation/activity-guide. The winter Stroll-ish and Holiday Makers Market were held on December 10, 2023. The Public Works Department is preparing for storms and providing sand for sandbags at Ocean View Park. East Bay Municipal Utility District (EBMUD) will perform urgent repairs on a water leak in the 1300 block of Solano Avenue. With the completion of Phase 8 of the Sidewalk Repair Program, the City has repaired more than 400 locations and addressed all issues designated critical.


8-1. City Council Strategic Plan 2023 – 2025 – Status Update

Staff Recommendation: That the Council receive a presentation providing a status update regarding progress towards implementing the 2023-2025 City Council Strategic Plan

City Manager Almaguer presented the status update for the City Council Strategic Plan. Staff has made significant progress in implementing the City Council Strategic Plan since its adoption eight months ago. Twenty-two of the 28 objectives contained in the Strategic Plan are underway or have been completed. Staff has also developed an Implementation Status Dashboard on the city website Almaguer provided a summary of projects and programs underway to further the City Council Strategic Plan and noted that the goals of the plan are also ingrained in the day-to-day operations of the City whenever practical.

9. PUBLIC HEARING

9-1. Amendments to the Zoning Ordinance to Update Accessory Dwelling Unit Regulations – First Reading

Planning & Zoning Commission and Staff Recommendation: That the Council introduce and waive the first reading of Ordinance No. 2023-07, repealing and replacing Section 20.20.080 "Accessory Dwelling Units" of the Albany Municipal Code and amending Sections 20.08, 20.12, 20.16, 20.24, 20.28, 20.40, 20.56, and 20.100 of the Zoning Ordinance to update Accessory Dwelling Unit Regulations

California Environmental Quality Act (CEQA):

Consideration of the ordinance is statutorily exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Public Resource Code 21080.17 and CEQA Guidelines Section 15282(h), which provide that CEQA does not apply to the adoption of an ordinance implementing the provisions of Section 65852.1 (Accessory Dwelling Units) or Section 65852.2 (Junior Accessory Dwelling Units) of the California State Government Code.

Planning Manager Leslie Mendez presented the staff report. The proposed amendments revise the Zoning Ordinance to comply with State law, correct life safety issues, and further facilitate ADU development. The Planning & Zoning Commission (PZC) twice reviewed proposed amendments, commented regarding height limits and setbacks, and unanimously recommended adoption of the draft ordinance.

Ordinance amendments include: elimination of the 0-foot setback and requirement of a minimum 3-foot setback to allow for emergency access; a 20-foot height limit for all detached ADUs; a 25-foot height limit for attached ADUs, with an exception to allow an additional 3 feet in order to match the height and pitch of the primary residence's roofline; elimination of any size limitation based on a proportion of the size of the existing primary residence; and exclusion of the square footage of detached and attached ADUs up to 800 square feet in size from both lot coverage and Floor Area Ratio (FAR) calculations.

The proposed ordinance simplifies the processing of ADUs by eliminating the two-tier ADU planning application and allows all ADUs to be processed through building permit only. Other amendments to simplify the ordinance include eliminating definitions not used in the ordinance, presenting development standards in table format, and other clean up amendments mainly for terminology consistency.

A summary of public comment is as follows: support for construction of ADUs and encouragement for electrification of ADUs; inquiries regarding the City website listing ADUs for rent and safety requirements for access to the second story of an ADU; an inquiry regarding affordable rents for ADUs; support for a 28-foot height limit, a 0-foot setback on one or two sides, and a 3-foot setback on two or three sides.

Planning Manager Mendez related that staff has no plans to list for-rent ADUs on the City website. A 20-foot height limit should allow the construction of stairs to the second story. The proposed ordinance does not include affordability requirements. On a single-family parcel, the maximum number of ADUs is three: one detached ADU, one converted ADU, and one JADU. A multifamily parcel can provide two detached ADUs and a minimum of one converted ADU and up to 25% of the number of existing units in the building. The Council may determine the setback for ADUs provided it does not exceed the state mandated 4-foot maximum.

A summary of Council comment is as follows: support for a 3-foot setback on all sides; appreciation for staff's thoroughness in reviewing State law and considering multiple scenarios; provisions of the ordinance can be revised in the future if they do not function well; the Council can adopt the proposed ordinance and direct staff to consider potential changes and review them with the PZC over the next year; and deliberation over increased height for detached ACUs to allow for pitched roofs.






