

7-7. Amendments to the Zoning Ordinance to Update Accessory Dwelling Unit Regulations – Second Reading, Pass-to-Print

Staff Recommendation: That the Council adopt Ordinance No. 2023-07, amending Chapter 20 of the Albany Municipal Code, Sections 20.08, 2012, 20.16, 20.20, 20.24, 20.28, 20.40, 20.56, and 20.100 regarding Accessory Dwelling Unit Regulations – Second Reading, Pass-to-Print

California Environmental Quality Act (CEQA):

Consideration of the ordinance is statutorily exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Public Resource Code 21080.17 and CEQA Guidelines Section 15282(h), which provide that CEQA does not apply to the adoption of an ordinance implementing the provisions of Section 65852.1 (Accessory Dwelling Units) or Section 65852.2 (Junior Accessory Dwelling Units) of the California State Government Code.

Mayor Miki asked if anyone wishes to remove items from the consent calendar. Council Member Jordan pulled Items 7-5, 7-6, 7-7, and 7-10.

Item 7-5: Council Member Jordan thanked members of Service Employees International Union Local 1021 for their work with the City.

Item 7-7: Community Development Director Jeff Bond reported the Planning and Zoning Commission (PZC) felt a 20-foot maximum height for a detached accessory dwelling unit (ADU) would provide flexibility in designing and constructing a two-story ADU. The Council may wish to obtain the PZC's opinion regarding a different maximum height.

Joanna Gin, City Attorney Office, advised that Ordinance No. 2023-07 is before the Council for second reading, and an amendment would return it to first reading of the Ordinance. Alternatively, the Council could postpone the second reading to a future meeting and obtain additional information prior to the second reading.

Item 7-10: Council Member Jordan appreciated staff's work on sidewalk repairs and the increased pace of repairs.

A summary of Council comment is as follows: Ordinance No. 2023-07 as proposed is acceptable; pitched roofs are preferable to flat roofs; a suggestion for staff to work with the PZC to explore incentives for pitched roofs complementary to the community.


12-A. Report for Housing Authority of County of Alameda (HACA)
