2 **A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING**
3 **THE SUBMISSION OF THE FISCAL YEAR 2024-25**
4 **PARATRANSIT APPLICATION IN THE AMOUNT OF \$94,054.83 TO**
5 **THE ALAMEDA COUNTY TRANSPORTATION COMMISSION**

6 **WHEREAS**, in November 2000, the voters of Alameda County approved the half-cent
7 transportation sales tax through the passage of Measure B, re-approving the tax measure
8 originally passed in 1986; and
9

10 **WHEREAS**, in November 2014, voters approved Measure BB which renewed the
11 half-cent transportation sales tax approved in 2000 and increases the tax by another half-cent;
12 and
13

14 **WHEREAS**, after nearly four decades, Measure B ended in March of 2021 and the
15 program remains funded through Measure BB until 2045; and
16

17 **WHEREAS**, the Alameda County Transportation Commission (Alameda CTC) has
18 the responsibility administering funds collected from the Measures and reviewing expenditure
19 plans; and

21 **WHEREAS**, Alameda CTC projections indicate that the City of Albany will receive a
22 total of \$94,054.83 to administer the Albany Paratransit Program; and
23

24 **WHEREAS**, the City has used Measure B and BB funding to implement the Albany
25 Paratransit Program since 1987; and

27 **WHEREAS**, the City’s Paratransit program includes subsidies on taxi rides, shopping
28 trips to local destinations, and recreational group trips throughout the Greater Bay Area.
