SUBJECT: Parking Enforcement Vehicle Purchase

REPORT BY: John Geissberger, Chief of Police

SUMMARY

The Police Department is seeking authorization to purchase one Westward Industries GO-4 Interceptor parking enforcement vehicle at a cost not to exceed \$41,000 (A contingency of approximately \$3,766 is included in this amount to cover unforeseen expenses that may be incurred). This vehicle will replace an older parking enforcement vehicle that is reaching the end of its service life.

STAFF RECOMMENDATION

That the Council adopt Resolution No. 2024-21, approving the purchase of one GO-4 Interceptor parking enforcement vehicle utilizing CIP funds, at a cost not to exceed \$41,000.

BACKGROUND/DISCUSSION

The selection and acquisition of a parking enforcement vehicle is constrained by the unique conditions under which these vehicles are required to operate and the significance of their daily service within the community.

The Go-4 parking enforcement vehicle will replace a 2015 vehicle that is reaching the end of its service life. The replacement vehicle will be purchased as a sole source product at a contract price of \$37,234. An additional amount for contingency of approximately \$3,766 is included in the request cost to cover unforeseen expenses that may be incurred.

Due to the unique design and requirements of the parking enforcement vehicle, it is recommended that this purchase be made on a sole source basis for the Westward Industries GO-4 Interceptor. It meets all of the operational requirements needed by the City. The GO-4 Interceptor is only available in California from Turf Star Western (Cart Star Motors, LLC).

SUSTAINABILITY CONSIDERATIONS

The City of Albany's Climate Action and Adaptation Plan calls for purchasing of low carbon vehicles and therefore this vehicle meets the operational requirement and needs of the Police Department as well as contributing to the goals of the Albany Climate Action and Adaptation Plan as it gets 45 miles to the gallon.

Staff researched zero-emission alternatives for parking enforcement vehicles but were unable to find a viable alternative at this time. In 2020 staff had researched the possibility of purchasing an electric version of this vehicle but found that the vehicles had significant mechanical issues that made the purchase untenable. Staff again explored this alternative purchase, but found the mechanical issues are still significant.

Staff will reconsider the all-electric Go-4, or similar models, when the technology has developed further.

FINANCIAL CONSIDERATIONS

The adopted budget for FY2023/24 included an appropriation from the Police Reserve Fund for the purchase of this parking enforcement vehicle.


