5. DISCUSSION AND POSSIBLE ACTION ON MATTERS RELATED TO THE FOLLOWING ITEMS:

5-1. Proposed Red Curb Restricted Parking at the Corner of Terrace Street and Tevlin Street

Review of a request from Waste Management to install approximately 30 feet of red curb on the north side of Terrace Street adjacent to 1513 Terrace Street to restrict vehicle parking to facilitate navigating the corner to provide service to the block.

Recommendation: That the Commission recommend that staff install approximately 10 feet of red curb on the north side of Terrace Street adjacent to 1513 Terrace Street to restrict vehicle parking and remove approximately 10 feet of red curb on the west side of Tevlin Street.

5-2. Sidewalk Repair Program – Phase 9 Project

Staff will provide an update on the Sidewalk Repair Program funded by the Measure P1 parcel tax, present the prioritization criteria, and present plans for Phase 9.

California Environmental Quality Act: The project is Categorical Exempt from California Environmental Quality Act (CEQA) pursuant to Section 15302 “Replacement or Reconstruction” of the CEQA Guidelines.

Recommendation: That the Commission:

1. Recommend that the City Council authorize the Sidewalk Rehabilitation Phase 9 project for construction of additional sidewalk improvements at the proposed locations as presented by staff.
2. Conditionally recommend the Phase 10 and Phase 11 projects for construction and the 2024-2026 repair schedule, where Staff will prepare a memo for Commission prior to seeking City Council authorization for construction.

5-3. Kains & Adams Bikeway Pilot Project Evaluation

In early 2023, implementation of the Kains and Adams Bikeway Pilot Project changed segments of Kains Avenue and Adams Street from one-way for vehicles and bicyclists to internal two-way traffic for vehicles, with permitted two-way through-movement by cyclists. Staff will present an updated evaluation of the pilot project and options to improve the design per the evaluation.

California Environmental Quality Act: The project is Categorically Exempt from California Environmental Quality Act (CEQA) pursuant to Section 15304 "Minor Alterations to Land" of the CEQA Guidelines.

Recommendation: That the Commission recommend that City Council:

1. Direct staff to prepare designs for a revised layout that includes: 1-way motor vehicle traffic, a contraflow bicycle lane, parallel parking, wayfinding signage, and additional intersection treatments to facilitate safer crossings; and
2. Authorize the City Manager to submit a grant application for the Kains & Adams Bikeway to the Caltrans Active Transportation Program and enter into a funding agreement with Caltrans upon award of grant.
