**RESOLUTION NO. 2024-23**

**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING  
THE CALL FOR BIDS FOR PHASE 9 OF THE ANNUAL SIDEWALK  
REHABILITATION PROGRAM (CIP NO. 22000)**

**WHEREAS**, the residents of Albany have recognized the need for safe, passable sidewalks to improve walkability throughout the City’s entire network; and


**WHEREAS**, under Section 5610 of the California Streets and Highways Code and per Albany Municipal Code Section 14-1.5b, property owners and persons in possession of property are required to maintain adjacent public sidewalks in a safe condition; and

**WHEREAS**, in November 2016, Albany voters approved Measure P1, a parcel tax for the purposes of publicly funding repairs to the City sidewalks; and

**WHEREAS**, in November 2020, the City Council approved Resolution No. 2020-108, adopting the FY2019/20 – 2023/24 Capital Improvement Plan and appropriating funds for the first three fiscal years of the Plan, including funding from the Sidewalk Parcel Tax Fund (1305) for the Annual Sidewalk Rehabilitation Program (CIP No. 22000), and updated the budget with additional appropriations in April 2023 (Resolution No. 2023-18a) and November 2023 (Resolution No. 2023-73); and

**WHEREAS**, on April 25, 2024, the Transportation Commission recommended that the City Council authorize construction of Phase 9 of the Sidewalk Rehabilitation Program; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby authorizes the Call for Bids for the Phase 9 Project of the Annual Sidewalk Rehabilitation Program (Contract No. C24-24).
