**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ALBANY,
CALIFORNIA, CALLING AND GIVING NOTICE FOR THE HOLDING OF
A GENERAL MUNICIPAL ELECTION ON TUESDAY, NOVEMBER 5, 2024,
FOR THE ELECTION OF MEMBERS OF THE CITY COUNCIL AND
MEMBERS OF THE BOARD OF EDUCATION AS REQUIRED BY
THE LAWS GOVERNING CHARTER CITIES**

**THE CITY COUNCIL OF THE CITY OF ALBANY, CALIFORNIA, DOES
HEREBY FIND, DETERMINE AND ORDER AS FOLLOWS:**

SECTION 1. Pursuant to Albany City Charter, Sections 5.01, 2.01, and 6.01, a General Municipal Election shall be held on Tuesday, November 5, 2024, for the election of three (3) Members of the City Council for a full term of four (4) years and two (2) Members of the Board of Education for a full term of four (4) years.

SECTION 2. On August 15, 2024 at 3:00 PM at Albany City Hall, a drawing will be held to determine the position of various candidate names on the ballot pursuant to Albany City Charter Sections 2.03 and 6.03.

SECTION 3. The ballots to be used in this election shall be in form and content as required by law.

SECTION 4. The City Clerk is authorized, instructed and directed to coordinate with the Alameda County Registrar of Voters to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment and paraphernalia that may be necessary in order to properly and lawfully conduct the election using proportional ranked choice voting at large in accordance with Measure BB approved by voters in 2020 and Chapter VII of the Albany Municipal Code.

1 SECTION 5. That the precincts, ballot drop box locations and hours of operations,
2 vote center locations and hours of operations, vote-by-mail procedures and timing, and election
3 officers, and all other persons and procedures for the General Municipal Election shall be the
4 same as those utilized by the County of Alameda.

6 SECTION 6. In all particulars not recited in this Resolution, the election shall be held
7 and conducted as provided by law for holding municipal elections.

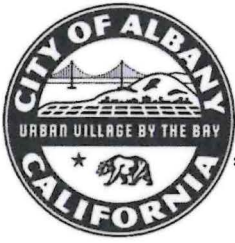
9 SECTION 7. The notice of the time and place of holding the election is given and the
10 Elections Official is authorized, instructed and directed to give further or additional notice of
11 the election, in time, form and manner as required by law.

12 SECTION 8. The City Council authorizes the Elections Official to administer said
13 election, and all reasonable and actual election expenses shall be paid by the City upon
14 presentation of properly submitted bills.

16 SECTION 9. The City Clerk shall certify to the adoption of this Resolution and shall
17 cause notice of the election, the offices to be filled, and other matters relating to the election to
18 be given as required by the Elections Code of the State of California.

20 SECTION 10. The City Clerk shall, not later than the 88th day prior to the General
21 Municipal Election to be held on Tuesday, November 5, 2024, file with the Board of
22 Supervisors and the Registrar of Voters of the County of Alameda, State of California, a
23 certified copy of this Resolution.
