CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

The Cleveland Avenue Bikeway Project, a phase of the Pierce Street Path Segment II, is categorically exempt from CEQA pursuant to Section 15301 “Existing Facilities” and Section 15333 “Minor Alterations to Land” of the CEQA Guidelines, which exempts the operation, repair, maintenance, or minor alteration of existing public facilities, involving negligible or no expansion of existing use.

3. To comment by video conference, click the “Raise Your Hand” button to request to speak when public comment is being taken. You will be asked to unmute yourself when it is your turn to make your comment. After the allotted time, you will then be re-muted.
4. To comment by phone, you will “Raise Your Hand” by pressing *9 to request to speak when public comment is being taken. You will be asked to unmute yourself by pressing *6 when it is your turn to make your comment. You will be re-muted after the allotted time.
