SUBJECT: Annual Sidewalk Rehabilitation Program (CIP No. 22000) Phase 9 –

Contract No. C24-24 Closeout and Filing of Notice of Completion

SUMMARY

Construction of Phase 9 of the Sidewalk Rehabilitation Program (Project), Contract No. C24-24, is complete. Staff recommends that the Council authorize the City Manager to approve to accept the improvements and file the Notice of Completion. No budget adjustments are needed at this time.

STAFF RECOMMENDATION

That Council adopt Resolution No. 2024-80, authorizing the City Manager to:

- 1. Accept the improvements completed in Contract No. C24-24; and
- 2. File the Notice of Completion with the County Recorder's Office.

BACKGROUND

In June 2016, the City Council adopted a new Sidewalk Repair Policy and placed a tax measure to fund sidewalk repair and replacement on the ballot. Albany voters approved this tax measure, Measure P1 in the November 2016 General Election, with collection of the tax to run for ten years. The Annual Sidewalk Rehabilitation Program (CIP No. 22000) was concurrently established to formalize this investment into a systematic approach to sidewalk repair in Albany. The Council recently adopted updates to the Sidewalk Repair Policy on June 17, 2024 in preparation for proposed updates to the Sidewalk Parcel Tax on the November 2024 ballot. The current policy can be found on the City's <u>Sidewalk Program webpage</u>.

Measure P1 as adopted in 2016 provides funding for repairs and includes a structure for staff to develop prioritization criteria which is then approved by the Transportation Commission. These criteria initially prioritized surveyed sidewalk issues within the Priority Sidewalk Network as identified in the Active Transportation Plan (ATP Network). In December 2020, the Transportation Commission approved modified repair prioritization criteria, where severe sidewalk issues were given higher priority regardless of location, followed by moderate issues

within the ATP Network. Updated prioritization criteria were approved again by the Transportation Commission in January 2022. This adjustment to the criteria was driven by a 2021 comprehensive Citywide sidewalk survey, funded using Alameda County Transportation Commission funds, which was used to compile a geographic information system database, allowing for an updated data-driven process to scope future repair locations. Phase 5 through Phase 8 prioritized repairs at the most hazardous locations identified from the sidewalk survey. Upon completion of Phase 5 through Phase 8, staff prepared modified repair prioritization criteria for recommendation to the Transportation Commission, which continued to utilize a data-driven process to scope future repair locations. In April 2024, the Transportation Commission approved updated prioritization criteria and recommended that the City Council authorize construction of the Phase 9 Project.

On July 1, 2024, the Council authorized the award of Contract No. C24-24 to Aris Concrete Contractor Inc. (Arias) for construction of the Project for the not-to-exceed amount of \$140,750.00 (Resolution No. 2024-57).

On October 31, 2024, the City Manager executed Contract Change Order #1 (CCO#1) for sidewalk repair at 1402 Solano (a special access needs issue reported after contract award) and for final quantity adjustments.

DISCUSSION

Arias started construction of the Project on August 15, 2024 and achieved substantial completion on September 27, 2024. The completed work includes:

- Rehabilitation of approx. 5,500 square feet of sidewalk; and
- Removal of approx. 100 square feet of sidewalk concrete to expand permeable surfaces for tree basins and planter strips.

The Project ultimately included sidewalk rehabilitation at a total of 40 locations; three locations were unresolved critical repair locations and two locations were special access needs issues. The Project is now complete and a Notice of Completion is required to be filed with the Alameda County Recorder's Office. The final contract amount of Contract No. C24-24 is \$157,140; refer to Attachment 2 for further information.

SUSTAINABILITY CONSIDERATIONS

The Project improved walkability, which is one of the City's sustainability goals. Sidewalk improvements afford greater mobility by disabled persons, strollers, and able-bodied persons in general. This promotes non-motorized travel, thereby reducing air emissions. The Project also supported goals adopted in the Active Transportation Plan.

SOCIAL EQUITY AND INCLUSIVITY CONSIDERATIONS

The Project has improved sidewalk conditions, which enhances accessibility and walkability within the City. This ultimately allows for greater pedestrian mobility of all ages and abilities, promoting and supporting active transportation.

CITY COUNCIL STRATEGIC PLAN INITIATIVES

This Project supported Goal 1 and Goal 3 of the City Council's Strategic Plan.

Goal 1: Advance Climate Action & Adaptation

The City's Climate Action & Adaptation Plan serves as an instructional plan that identifies programs and projects that are intended to reduce greenhouse gas emissions, as well as measures to adapt to climate change impacts. Transportation is identified as the highest source of greenhouse gas emissions in Albany and increasing active transportation, such as walking, is a priority. This Project improved sidewalk conditions, which enhances accessibility and walkability within the City.

Goal 3: Promote Streets that Support Safety & Transportation Mobility Options

The City's Local Roadway Safety Plan in connectivity with the Active Transportation Plan (ATP) help guide transportation and mobility enhancement projects within the City. The ATP identifies upgrading sidewalks, as was performed under this Project. In addition, sidewalk improvements afford greater mobility by disabled persons, strollers, and able-bodied persons in general, promoting active transportation (i.e. non-motorized travel).

FINANCIAL CONSIDERATIONS

The Project is primarily funded as part of the City's Annual Sidewalk Rehabilitation Program (CIP No. 22000). The current budget for this program was approved by Council as part of the City's Capital Improvement Program in November 2020 (Resolution No. 2020-108) with additional appropriations from Sidewalk Parcel Tax reserves in April 2023 (Resolution No. 2023-18a), November 2023 (Resolution No. 2023-73), and July 2024 (Resolution No. 2024-57).

The following table details Contract No. C24-24 expenditures and changes:

The Project predominantly utilized funding from the Annual Sidewalk Rehabilitation Program (CIP No. 22000). Costs for the special access needs repair under CCO#1 utilized operating budget funds appropriated previously for the Public Works Public Right of Way Maintenance Program in the amount of \$4,505.50. Project expenditures are outlined in further detail in Attachment 2 to this report.

The following table details the total appropriated budget and funding sources for the **Annual Sidewalk Rehabilitation Program** (CIP No. 22000) to date:

That the said City of Albany is in possession of said real property and owns a fee simple estate or an easement for public use therein.




