

**WHEREAS**, Frank Segovia has served the City of Albany and the Albany Police Department in a professional, dedicated and loyal manner; and

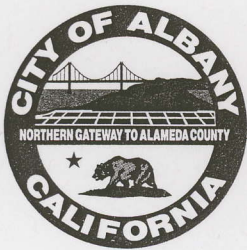
**WHEREAS**, Frank Segovia after twenty-five years of faithful service, will retire from the Albany Police Reserves on November 1, 2008;


