

LIST OF SCHOOL SAFETY MEASURES ALBANY ELEMENTARY SCHOOLS

Marin Elementary

1. **Santa Fe/Marin Ped. Island** - Pedestrian refuge island at the intersection of Marin Ave. and Santa Fe – 2004
2. **Curtis Bulbouts** - Sidewalk extensions at SW/c and SE/c of Marin Avenue and Curtis St. to slow turning cars and shorten street crossing for pedestrians—2004
3. **Santa Fe Islands** – added landscape islands on Santa Fe at Ramona and Pomona Streets to slow traffic- 2004
4. **Marin Avenue Traffic Calming** - Realigned street from four lanes to two lanes + turn lane + bike lanes (took eight years from 1998 concept to implementation in 2005 due to years of public meetings and need for a number of technical studies)
5. **Distribution of flyer:** Safety Around Schools in three languages—2005, 2006, 2007
6. **Drop-off and Pick-up** – added spaces on Santa Fe and Curtis, installed signage; red curbed unsafe areas —2006
7. **Surveyed existing conditions** (Walking Audit) with the assistance of Fehr and Peers (Traffic Engineering consultant) as part of the Pedestrian Plan to identify traffic hazards around schools—2007 map attached.
8. Submitted grant proposal to replace the **traffic signal at Marin Ave. and Santa Fe Ave.** with pedestrian countdowns 2007 – Grant not received; will be resubmitted.
9. **Marin Avenue Restriping** – follow-up to Marin Traffic Calming project – added zebra striping at crosswalks, Keep Clear, No Right Turn on Red (NRTOR) signs around Marin School area – 2008
10. Implementation of the **Safe Routes to School Educational Program at Marin Elementary** for parents and teachers – 2008
11. **Crossing Guards** – located at Marin/Santa Fe, Solano/Santa Fe

Ocean View Elementary

1. **Buchanan Flashing Beacons** – Installed two flashing beacons on Buchanan Street near Madison Street (northside) and between OV School and Park (southside) — 2003
2. **Pierce Street Sidewalk** – replaced dirt shoulder with sidewalk on uphill side of Pierce Street at base of Albany Hill
3. Distribution of **flyer: Safety Around Schools**—2005, 2006, 2007
4. **Surveyed existing conditions** (Walking Audit) as part of the Pedestrian Plan—2007 Map attached
5. Implementation of a **Safe Routes to School Educational program** for parents and teachers
6. **Jackson/Buchanan Traffic Signal** + other improvements – new light with protected left turns, countdowns, two solar speed feedback signs, ADA ramps on the route to school on Solano at Madison St., and zebra striped crosswalks on the walking route along Buchanan St. and Solano Avenue – summer 2009
7. **Buchanan Bicycle/Ped Path** – planned multi-use path on Buchanan Street between San Pablo Avenue and Buchanan Bridge overcrossing – in planning process
8. **Crossing Guards** – located at San Pablo/Marin, Jackson/Buchanan, Jackson/Solano

Cornell Elementary

1. **Drop-off and Pick-up** – modified spaces somewhat on Cornell and Talbot, added ADA accessible space —2004
2. Distribution of **flyer: Safety Around Schools**—2005, 2006, 2007
3. **Surveyed existing conditions** (Walking Audit) as part of the Pedestrian Plan—2008 Map attached
4. Initial efforts to implement a **Safe Routes to School Educational Program**—International Walk and Roll to School Day—2008 Picture attached
5. Implementation of a **Green Schools** effort with the assistance of City's Environmental Planner.
6. **Crossing Guards** – located at Solano/Talbot, Solano/Cornell, San Pablo/Solano, Marin/Cornell
