A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY OF ALBANY FIRE DEPARTMENT TO CONTRACT WITH REVENUE RESCUE FOR THE COLLECTIONS OF FIRE ENGINE RESPONSE FEES.

WHEREAS, Revenue Rescue is a nationwide professional billing company specializing in facilitating reimbursement for fire responses

WHEREAS, Revenue Rescue currently contracts with over 600 fire departments throughout the nation

WHEREAS, fire response billing range from hazardous materials responses to vehicles accidents and all types of fires

WHEREAS, insurance companies recognize fire engine responses charges and reimburse cities for such charges

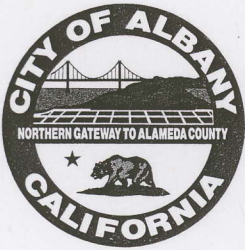
WHEREAS, an estimated gross annual collection of \$25,000 to \$35,000 can be expected for this new service


