a. 1600 Posen Avenue, Albany*. Planning Application 06-091. Design Review. Request for Design Review approval of structural and landscape elements of the Saint Mary's College High School Athletic Field Renovation Project.

(*The site is also known by the mailing address of 1294 Albina Avenue, Berkeley)

Staff recommendation: Public Hearing to receive public comments on a Draft Mitigated Negative Declaration.

b. 521 Talbot. Planning Application 06-088. Design Review. Conditional Use Permit. A request for Design Review approval to allow construction of a new 803sq.ft. addition, which would create a 1,606sq.ft. home. The applicant is requesting a conditional use permit to allow the extension of a nonconforming north wall, which has a 1'-9" side yard setback where 3'-9" is required.

Staff recommendation: approve.

c. 930 Fillmore. Planning Application 07-033. Design Review. Parking Exception. A request for Design Review approval to allow construction of a new 640sq.ft. second-story addition to a 1,938sq.ft. home. The applicant is requesting a parking exception to allow one off-street parking space where 2 are required.

Staff Recommendation: approve with revisions.

d. Environmental Review Consultant for University Village Retail Development Project. Discussion of staff intention to submit a consulting contract to the City Council related to the California Environmental Quality Act (CEQA) review of an anticipated application for a mixed-use project at University Village, located at San Pablo Avenue and Buchanan Street.

Staff recommendation: For information and discussion only.

e. Green Building Program Standards of Compliance.

Staff recommendation: That the Commission recommend to the City Council adoption of Single Family Residential, Multi-Family Residential and Commercial Green Building Program Standards of Compliance.
