- c. **1047 Stannage. Planning Application 07-020.** Design Review. A request for Design Review approval to allow construction of a new 1,390sq.ft., two-story addition to the rear area of an existing single-story home. All development requirements are met and only Design Review approval is requested. *Staff recommendation: continue to the April 24, 2007 hearing date due to lack of quorum.*

a. 1161-1175 Solano. Planning Application 07-017. Parking Exception. Design Review. A parking exception is requested to allow 21 parking spaces where 24 are required. Future or expanded uses of the building may require other city approvals. Staff recommendation: This is a study session so no action is taken at this time.
