5. GOOD OF THE CITY/PUBLIC FORUM/ANNOUNCEMENTS

For persons desiring to address the City Council on an item that is not on the agenda please note that City policy limits each speaker to three (3) minutes. The Brown Act limits the Council's ability to take and/or discuss items that are not on the agenda; therefore, such items are normally referred to staff for comment or to a future agenda.

The following people spoke: Joan Larson, Albany resident; Caryl O'Keefe, Albany resident; Brian Parsley, Albany resident.

A summary of the comments is as follows: Announced a reception for the display of the Centennial Quilt on Monday, April 20, 6:30 – 7:30 p.m., Community Center. Reported that the Friends of the Library held a book sale and collected \$2,300 and announced that another book sale would be held on May 16 & 17. Thanked Ronnie Davis, Marsha Skinner and Joan Larson for their work on the book sale. Spoke about the

acquisition and restoration of the Albany bulb and noted that the bulb is the "jewel of the Eastshore State Park" and that Albany citizens should be reimbursed for the land.

Council Member Wile commented on an article in the Berkeley Daily Planet regarding the Solano Avenue "Art Attack" noting the first event was successful. The event is the first Friday evening of each month and would encourage people to participate.

Council Member Wile spoke about the 2-1-1 Social Service programs that are available to Albany residents who are experiencing difficulties and urged people to use this resource.

6. PRESENTATION

6-1. Library Proclamation

Mayor Atkinson read a proclamation recognizing Library Week in the City of Albany and presented it to the Chair of the Library Board.

6-2. Golden Gate Fields Bankruptcy Filing

The City Administrator reported that the owner of Golden Gate Fields, Magna Entertainment Corporation (MEC) filed for Chapter 11 bankruptcy protection on March 5, 2009. Racing operations are currently continuing at Golden Gate Fields in Albany while MEC assets are in transition. MEC has proposed a restructuring plan in which its primary creditor and shareholder Magna International Developments, Inc (MID) would acquire the racetrack.

However, it is possible that the tracks and other assets could be individually or collectively purchased by another entity not affiliated with MID or MEC. The sale of the MEC assets to MID or to another entity is currently expected to occur in July.

The City Administrator stated that any potential buyer of the property should be aware of the City's Measure C and Voices to Vision project.

Mr. Robert Hartman, General Manager of Golden Gate Fields, explained Chapter 11 bankruptcy noting this provides debtors a way to restructure its debt. A loan has been approved so that operations at Golden Gate Fields can continue. There is a Court approved plan that must be followed and the Court is the controlling body that will set the rules. It was noted that Golden Gate Fields is included in a "stalking horse bid" and Santa Anita is not included.

Mr. Hartman stated that by the end of August Golden Gate Fields would probably have a new owner and would continue operations through the entire process.

Council Member Wile thanked Mr. Hartman for coming to the meeting and explaining the proceedings.

Mayor Atkinson asked whether Measure C and the Voices to Vision project would influence a buyer. Mr. Hartman responded yes and the City definitely should notify all prospective buyers of the various conditions of that property.

6-2. Golden Gate Fields Bankruptcy Filing

The following person spoke: Mr. Edward Moore, Berkeley and a summary of the comments is as follows: Spoke about the various motions that have been filed and that no actual dollar value has been put on a particular asset and noted that a bidder could very well bid on a separate asset.

7. UNFINISHED BUSINESS

7-1. Resolution No. 09-10 – Loan Agreement (File #600-30)

The Finance Director reported that previously the Council approved the issuance of a bond to finance the Nielson Curtis storm drain improvements; however the bond underwriters discovered that a privately placed negotiated loan would provide the City the same terms as a public issue of bonds but at a lower cost to the City. The interest rate on the loan would be 4.6% for a term of 12 years with options to prepay the loan beginning August, 2014.

As approved for the previously approved bonds, parcel tax revenue from the storm drain and street paving parcel tax would be pledged for repayment of the loan. Semi-annual payments of interest and principal would be \$195,692.

Council Member Lieber presented Resolution No. 09-10 – A Resolution of the Albany City Council, State of California, Authorizing the Execution of a Loan Agreement with Capital One Bank and Delivery of a Note for the Purpose of Financing the Cost of Acquiring and Constructing Storm Drain Improvement Projects and Related Matters and Amending Resolution No. 09-07.

8. NEW BUSINESS

8-1. Resolution No. 09-13 – Acquisition of 842 Masonic (File #670-20)

The Planning Manager reported that in previous action the City Council explored the possible acquisition of the home for sale at 842 Masonic to be used for expansion to the Albany Senior Center.

The Parks & Recreation Commission discussed the possible acquisition and approved a motion supporting the expansion of the Senior Center, but expressed serious concerns about the financial implications and impacts on other Parks and Recreation Master Plan priorities.

8-1. Resolution No. 09-13 – Acquisition of 842 Masonic

The Planning & Zoning Commission unanimously expressed support for the expansion.

The Planning Manager noted that this acquisition would be considered Categorically Exempt from the requirements of the California Environmental Act (CEQA). An appraisal was conducted and valued the property at \$425,000, which is the purchase price.

Council Member Lieber stated that he is very excited about this acquisition and is also aware of the tough economic times right now but believes it is worth spending the money and noted that it is a fraction of the cost for purchase of the Veteran's Building.

Mayor Atkinson stated that she also supports this acquisition noting that there is definitely a need in Albany to expand the Senior Center.

Council Member Lieber presented Resolution No. 09-13 – A Resolution of the Albany City Council Authorizing Purchase of Property at 842 Masonic Avenue for Purposes of Future Expansion of the Albany Senior Center.

Council Member Javandel announced the following: 1) Attended the Little League Opening Day and Parade. 2) Encouraged everyone to participate the upcoming Bike to Work day noting that there are team challenges and urged the Council to get a team together.
