A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING CITY STAFF TO IMPLEMENT AN RFP TO HIRE A CONSULTANT FOR THE ALBANY ARTS COMMITTEE PUBLIC ART MASTER PLAN.

WHEREAS, the Albany Arts Committee has been working on a Public Art
Master Plan and has established a table of content which includes the following sections:
Introductions and Goals, Sites and Criteria, Selection Process and the Art Ordinance as an appendix; and

WHEREAS, the Albany Arts Committee would like to hire a professional art consultant to assist with the creation of the Sites and Criteria section of the Public Art Master Plan; and

WHEREAS, the Site and Criteria section will determine specific sites and establish criteria for each site within the City where public art could be displayed; and

WHEREAS, when selecting art projects to undertake, the Arts Committee will use the information contained in the Sites and Criteria section of the Public Art Master Plan to make the best use of the funds available; and

WHEREAS, the cost for the scope of work of the art consultant will not exceed \$11,000.00 and will be paid from the Percent for the Arts Fund;

NOW THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorizes city staff to issue a Request for Proposals to hire a consultant for the Albany Public Art Master Plan.
