NEILSON STORM DRAIN AND SANITARY SEWER IMPROVEMENTS**


WHEREAS, by agreement dated July 21, 2008, the City of Albany contracted with Ranger Pipeline Inc. to construct Contract No. C07-21, Neilson Storm Drain and Sanitary Sewer Improvements, in accordance with the official plans and specifications prepared therefor, copies of which are on file in the Community Development Department office; and,

NOTICE OF COMPLETION AND ACCEPTANCE OF PUBLIC WORK

That said City of Albany is in possession of said real property and owns a fee simple estate or an easement for public use therein;

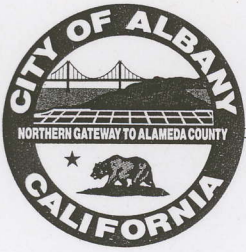


