2008 SEWER PROJECT-EAST SIDE OF ALBANY HILL**



WHEREAS, a Notice of Completion has been prepared, a copy of which is attached hereto, marked Exhibit "A," and included herein by reference; and,

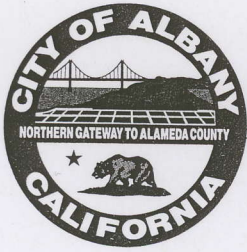


