PARCEL 7: SAN FRANCISCO BAY AREA RAPID TRANSIT DISTRICT PARCEL #R31-1-3B as identified as Parcel R31-1-3B and shaded in **Exhibit 1**, attached and incorporated by reference hereto.

Grantor hereby provides a Right of Entry to perform work as set forth in the Acquisition Agreement of the date herewith by and between the City of Albany and the San Francisco Bay Area Rapid Transit District.

This Right of Entry is for a period of forty-two (42) months between December 1, 2009 and June 30, 2013. Possession and use of each PARCEL within the Right of Entry area (also referred to as Temporary Construction Area on Exhibit "1" attached hereto) is anticipated to be required on the average of seven (7) months within the said forty-two month period. The consideration paid includes full payment for such possession and use for the average seven (7) month period. Upon expiration of this Right of Entry after said forty-two month period, Grantee's rights shall revert automatically to Grantor.

Grantee shall give Grantor at least 45 days advance written notice prior to entry. At or before the issuance of the notice of entry, Grantee shall submit a project timeline. Right of Entry shall be contingent upon Grantor's receipt and approval of said project timeline. The construction sequence for each city block shall proceed and be completed considering Grantor's requirements and with least impact to the public. Grantee shall restore the Right of Entry area as set forth in the Acquisition Agreement and the plans and specifications approved in the bid documents. Grantor and its representatives, employees, agents or independent contractors may enter said property, as follows, provided such use does not unreasonably interfere with Grantee's rights herein:

- a. maintenance of sanitary sewers, open storm drain channels, irrigation mainlines and electrical wiring;
- b. emergency response;
- c. inspection of said property or any portion thereof or any improvements thereon at any time and from time to time at reasonable times to verify Grantee's compliance with the terms and conditions of this Right of Entry;
- d. construction of improvements to meet federal grant deadlines for the Highway Safety Improvement Program and Safe Routes to Transit Program.
