# STAFF RECOMMENDATION

Staff recommends that the Planning and Zoning Commission open the public hearing, take testimony from the public, provide any appropriate direction or conditions, and approve the project.

# BACKGROUND/PROJECT DESCRIPTION

The subject property is a 5,300 sq. ft. lot with a 1,427 sq. ft., single-story duplex. The applicant is requesting conditional use permit and parking exception to allow a large family day care to operate at the site. The applicant and immediate family members occupy both of the units as their primary place of residence. The applicant is requesting a conditional use permit to allow a large family day care, which allows a maximum of 14 children at any one time, to be operated at 742 Masonic. The day care is proposed to operate Monday through Friday from 8:00am-6:00pm. Drop-off and pick-up hours vary, as does the number of children in attendance. Midday is typically the time with the highest number of children. The granting of a conditional use permit would allow fourteen children, less than eighteen years in age, to be taken under care at the home.

There will be up to two full-time employees, depending upon the number of children attending for the day. As previously stated, there is a duplex, with one unit that is approximately 770sq.ft. in size (subject property) and the other that is 657sq.ft. in size (744 Masonic). The applicant would like to use the rear yard and western side yard for play area. The State of California Department of Child Care Licensing Department does not have a square footage requirement for family day cares, like it does "child care centers." The only occupancy requirements are set forth by the Fire Department. This property would be required to install an alarm system, but would not have issues with occupancy.

There is a two-car carport on the northeast area of the property. The carport nonconforming in that it is located in the front yard where parking is not permitted without a front yard parking exception. The Planning and Zoning Code requires that two off-street parking spaces be provided for single-family homes and the applicant is required to provide an additional parking space for any other employees.

#### **ENVIRONMENTAL ANALYSIS**

Staff has determined that the proposed project is categorically exempt from the requirements of CEQA per Section 15303(a) of the CEQA Guidelines, which exempts one single-family residence or a second dwelling unit in a residential zone.

#### **DISCUSSION OF KEY ISSUES**

State law (Section 1597.465 of the California Health and Safety Code) has imposed specific limitations on the City's ability to zoning authority for several type of land uses, including child care facilities. Small family day cares with eight or fewer children are permitted without city review, as stated by state regulations. Large family day care facilities, for up to fourteen (14) children, are considered an allowed use in a single-family residential neighborhood where an occupant of the residence provides care and supervision, and thus the City's authority to review these activities is limited to the following:

- Municipal Code Section 20.20.020 states that "large family day cares shall not be abutted
  on more than one side by any combination of a large family day care, a day care center
  or a residential care home." These limitations are not factors with this application.
- The Municipal Code also states "no large family day care home or day care center shall be permitted if any other licensed large family day care home or day care center is located within three hundred (300) feet of the lot subject to the application. The State of California Department of Child Care Licensing Department maintains a list of all large family day cares (Attachment 2). There are no similar facilities located within 300' to the subject property.

As previously stated, the property is a duplex, occupied by the applicant and immediate family. Theoretically, the applicant could apply for two small family day cares, one at each unit, which would not require any discretionary review. The applicant has chosen to request a conditional use permit to allow one, large family day care in the interest of full disclosure, comprehensive review and with the hope of no questions of legitimacy in the future.

#### Parking Exception

Municipal Code Section 20.20.020 requires that one off-street parking space be provided for each full time employee. As previously stated the home is legal nonconforming in that there is only two off-street parking spaces for the two units, in the form of a carport in the front yard. The applicant is requesting a front yard parking exception to allow the two parking spaces to be allocated towards the subject property and a parking exception to meet the employee parking requirements.

Staff conducted a parking count, within an approximately 500' radius of the site, at 8:30a.m. on Friday, September 4, 2009. There was a 49.2% vacancy rate, which means that only about half of the on-street parking spaces were occupied. Staff also drove by the site and neighborhood on Tuesday, September 1 at 6:00p.m. and Wednesday, September 2 at 5:00p.m. and found that there were many available parking spaces around the site, within an approximately 500' radius.

The site is located next to the BART tracks and there is generally a higher number of spaces along the entire track. The young age of the children requires that parents park and walk into and sign up at the day care center. Thus, issues of pedestrian safety are less significant than they would be around a school serving older children.

#### Conclusion

Staff believes the day care could be an asset if managed properly, and recommends approval of the conditional use permit and parking exception with the following condition of approvals: 1) The carport shall remain clear of obstructions and utilized by staff of the day care; 2) Parents shall abide by all traffic laws and use only legal, designated areas for parking during drop-off, pick-up and all other day care related trips; 3) All parents shall sign a contract agreeing to the stipulations of the previous conditions; 4) All fences in the rear yard shall be replaced with a new, solid, 6' tall fence to help serve as a noise barrier; 5) The applicant shall distribute a day care contact phone number to all neighbors within 100' radius and respond to any concerns or complaints from neighbors; and (6) schedule activities so that there are "quiet-time" breaks where all children are indoors.

# **ATTACHMENT 3 - CONDITIONS OF APPROVAL**

- 1. This Conditional Use Permit and Parking Exception approval is for approval to allow a large family day care to operate at 742 Masonic, except as may be modified by conditions herein. Plans include a site plan/floor plans/elevations submitted by Dezhen Lai, dated received by the Community Development Department on August 8, 2009, and presented to the Planning and Zoning Commission at its meeting of September 9, 2007.
- 2. The applicants shall pay any and all City and other related fees applicable to the property. Fees shall be based on the current fee structure in effect at the time the relevant permits are secured, and shall be paid prior to issuance of said permit or prior to any City Council final action approval. Notice shall be taken specifically of Plan Check and Inspection Fees.
- 3. All fences in the rear yard shall be replaced with a new, solid, 6' tall fence to help barrier noise.
- 4. The applicant shall distribute a day care contact phone number to all neighbors within 100' radius and make a good faith effort to respond to any concerns or complaints from neighbors.
- 5. All signage shall be reviewed an approved for design review by staff.
- 6. The carport shall remain clear of obstructions and utilized by staff of the day care.
- 7. Parents shall abide by all traffic laws and use only legal, designated areas for parking during drop-off, pick-up and all other day care related trips and sign a contract agreement agreeing to the stipulations.
- 9. All exterior lighting shall be installed in such a manner that glare is directed away from surrounding properties and rights-of-way.
- 10. Schedule activities so that there are "quiet-time" breaks where all children are indoors.
- 11. Pursuant to Government Code Section 66474.9, the applicants (including any agent thereof) shall defend, indemnify, and hold harmless, the City of Albany and its agents, officers and employees, from any claim, action, or proceeding against the City or its agents, officers or employees to attack, set aside, void, or annul the City's approval concerning this application, which action is brought within the time period provide for in Section 66499.37. The City will promptly notify the applicants of any such claim action or proceeding and cooperate fully in the defense.

**Appeals**: The Albany Municipal Code provides that any action of the Planning and Zoning Commission may be appealed to the City Council, if such appeal is filed within 14 days of the date of the action. Appeals may be filed in the Community Development Department by completing the required form and paying the required fee. The City Clerk will then schedule the matter for the next available City Council meeting.

# **How the Daycare Center Started**

The Albany Family Daycare center was opened at the strong request of Albany parents.

After the Berkeley Chinese Preschool on Jackson Street in Albany was closed in June 2006, many parents struggled to find daycares or preschools for their children. They looked long and hard, but did not find centers that satisfied their needs and desires. At that point, several of them turned to me. I had been teaching at the Berkeley Chinese Preschool since May 2005 and had developed strong bonds with the children and a very positive and trusting relationship with the children's families.

The parents suggested that I open a family daycare in Albany, and called me many times to convince me to do so. I understood the vision that the parents had of the daycare they wanted for their children: most important was a knowledgeable and experienced teacher with a caring staff. They also wanted a safe and joyful educational environment, good instructions in Chinese, and nutritional meals. I knew that I could offer this to children under my care.

After serious consideration and many meetings with the parents, I decided to move my family to the current location at 1068 Stannage Ave in Albany in December of 2006. Careful planning and thorough preparations were done before the California state license was issued in January of 2007.

The daycare opened on January 31, 2007 with only 4 children, its good reputation has spread quickly and widely since then; indeed, the daycare now has a waiting list. We have always aimed to be of service the city of Albany and its families; since opening our daycare, 75% of the children we have cared for have been from Albany families.

The daycare was opened at the request of parents; it provides an essential service to the children of Albany and its community. Please allow it to continue its services at its new proposed location on Masonic Ave. Thank you.

# Relations with our Neighborhood and Participation in the Community of Albany

#### RELATIONS WITH OUR NEIGHBORS

Maintaining good relations with our neighbors has been central to the operation of the daycare. We have maintained friendly relations with our current neighbors on Stannage Ave. In fact, we have never received any complaint from our neighbors; quite the contrary, our neighbors like the children and their cheerfulness. In addition, at times we have taken care of our neighbors' children, and have received donations of toys from them.






# Parking Report

(August, 2009)





On Masonic Ave between Washington and Portland

On Masonic Ave between Washington and Solano Ave

**Parking is not a problem at all**. The proposed family day care site offers adequate parking spaces it will need. The site is a corner house with 154 feet curb which translates into six (6) parking spaces right in front of the house: four (4) curb parking spaces on Masonic Ave; two (2) on Washington Ave., There are many rarely used parking spaces under the BART rail across the street from the house on Masonic Ave. The recording of the three day observation proves this statement. The three day observation was done during drop-off and pick-up hours, considering that the concern, if any, is that there might be traffic flow increase during these hours. Since the operation hours of the daycare are from 8: 00 am to 6:00 pm, traffic peak hours will be 8 to 9:30 am and 4:30 to 6:00 pm.



The results of our observations have been very consistent from day to day. According to the observation, the average available parking spaces at any time are about twenty just on Masonic Ave between Washington and Portland. This number is even greater than the number of children we accept. Additionally, not all parents will arrive at the same time, nor will they pick up their children at the same time; some of the families will arrive on foot, by bike or by carpool. Since this is a family operated daycare with limited capacity, we don't anticipate any long time parking impact posed by the daycare at all.

# Noise Control Policy

(August, 2009)

The proposed site of the daycare is on the corner of Washington Ave and Masonic Ave in Albany, California. There are two immediate neighbors: one dwelling to the west on Washington Ave, and one dwelling to the north on Masonic Ave. BART rails are across the street on the eastern side of Masonic Ave.

Spending time outdoors is crucial to the healthy growth of children of all ages. Outdoor playgrounds provide fun, fresh air, exercise and ultimately help in the development of happy young people. Being outdoors is also one of the best ways for children to learn about the environment they live in through self discovery. Additionally, realizing that others live, eat, work, study and play in nearby homes, allows children to learn how to respect neighbors and others with whom they interact. Learning to be good neighbors and good citizens is part of growing up. This is why it is one of the daycare's goals to teach our children to be in control of the noises they make in their daily lives. When teaching our children how to control their voices, we teach them how to communicate in a variety of social environments. In other words, we teach them to control the tone and loudness of their voices when expressing their emotions and desires during indoors and outdoors play and music-time.

The following outlines our policy regarding noise control:

- The daycare backyard will serve as playground area; this will be the location where our children will play during most recess hours. We plan to install sound-absorbing rubber tiles in the playground area as part of our noise-mitigation efforts.
- To minimize any possible impact, play structures will be placed at the southern end of the backyard. In other words, they will be placed away from the neighbor who might be most affected by the children during play-time.

- 3. Weather permitting, we plan to take our children to nearby parks so that recess is not spent only in our own playground area every day.
- 4. We will teach our children the importance of being considerate when outdoors. When necessary, we will ask the children to lower their voices. Teaching children to be good neighbors and be mindful of other people's needs will always be part of our curriculum.
- 5. The number of students in our play-area will not exceed fourteen at any given time. The teacher-student ratio will be 1:7 (or better) during outdoor play time to assure adequate supervision.
- 6. We encourage our neighbors to contact Ms. Lai (director of the daycare) in person or by calling (510) 559-3178 if they have any concerns or complaints about our playground's noise level. Any concerns or complaints will be addressed immediately and will be followed up with a return phone call or a letter.

**Dear Albany Planning & Zoning Commission:** 

I am writing to you to express my strong and enthusiastic support for the Conditional Use Permit Application of Albany Family Day Care (Lai Dezhen Day Care) at 742 Masonic Avenue in Albany.

I am writing to you first as a parent whose daughter was under Ms. Lai's care for more than two years. I first knew Ms. Lai when she was a preschool teacher at Albany Berkeley Chinese School when my daughter was a student. She was one of the most dedicated, responsible, and talented teachers there. She does not teach Chinese the traditional way; instead, she uses rhymes, stories, songs, and dancing to encourage children's all-around development. Needless to say, she was my daughter's favorite teacher. When Albany Berkeley Chinese School was closed in June 2006, I had to send my daughter to an English Montessori school in Albany. While she did receive excellent care there, she quickly lost her Chinese language skills. As a desperate mother, I and several other parents urged Ms. Lai to open a family day care for many parents like us looking for a quality Mandarin day care in this area. When she eventually opened her family day care in early 2007 at 1068 Stannage Avenue in Albany, I was ecstatic. I drew my daughter from her Montessori school and enrolled her at Ms. Lai's day care. She stayed there until entering Kindergarten. My daughter received the best quality of care and teaching while she was at her day care. As a mother, there is nothing more to ask for to have the peace of mind when you send your child to a day care.

I am also writing to you as a fellow colleague of Ms. Lai in providing Chinese language and cultural education to children in the East Bay Area. I am the Head of Shu Ren International School in Berkeley, a Mandarin immersion school currently serving children from age 3 to second grade. In the past two years since I started to work on Shu Ren, I have talked to many parents looking for Mandarin immersion schools at various age levels. Often, they asked about how they could find a quality Mandarin day care for their younger child (we only admit children 3 and older). Over and over again, I recommended Ms. Lai. Undoubtedly, her day care has been an tremendous asset to the city of Albany considering there are not many other large family day cares in Albany, and to the best of my knowledge, her day care is the only Mandarin-



speaking large family day care. Given the surge in interest among parents to teach their children Mandarin, we need more family day cares like Ms. Lai's, not less.

Finally, I like to testify Ms. Lai's character having known her for more than three years. She is honest, dependable, sincere, and trustworthy. She cares deeply about children, their families, and the community. She is very sensitive to neighbors' concerns and willing to work together to solve them. Below I will briefly discuss a couple of potential issues and suggest how they may be addressed.

- Traffic. The large family day care can accommodate 14 children at most. Some live nearby and can walk to her house. In addition, her day care's scheduling is not structured like a school, thus drop-off and pick-up is expected to be scattered throughout the day, reducing the possibility of stacked cars or numerous vehicles at the site. Even if there may be a peak hour of dropping off, a drive-by drop-off can be easily instituted.
- 2. <u>Noise</u>. The effect of noise can be mitigated by moving the play area away from neighbor's house. The site has outdoor play area in all directions which allows the flexibility of only using the section away from the neighbors' house. In addition, children's playtime in the outdoor is usually limited to 1-2 hours a day, thus, the effect is also limited.

In sum, I strongly believe that a large family day care like Ms. Lai's provides very valuable community services to families in the city of Albany and surrounding places and should be continued. There is nothing that cannot be resolved through dialogue and careful planning. Therefore, your approval of her application will be greatly appreciated.

I am writing to you to express my strong and enthusiastic support for the Conditional Use Permit Application of Albany Family Day Care (Lai Dezhen Day Care) at 742 Masonic Avenue in Albany.

I am writing to you first as a parent whose daughter was under Ms. Lai's care for more than two years. I first knew Ms. Lai when she was a preschool teacher at Albany Berkeley Chinese School when my daughter was a student. She was one of the most dedicated, responsible, and talented teachers there. She does not teach Chinese the traditional way; instead, she uses rhymes, stories, songs, and dancing to encourage children's all-around development. Needless to say, she was my daughter's favorite teacher. When Albany Berkeley Chinese School was closed in June 2006, I had to send my daughter to an English Montessori school in Albany. While she did receive excellent care there, she quickly lost her Chinese language skills. As a desperate mother, I and several other parents urged Ms. Lai to open a family day care for many parents like us looking for a quality Mandarin day care in this area. When she eventually opened her family day care in early 2007 at 1068 Stannage Avenue in Albany, I was ecstatic. I drew my daughter from her Montessori school and enrolled her at Ms. Lai's day care. She stayed there until entering Kindergarten. My daughter received the best quality of care and teaching while she was at her day care. As a mother, there is nothing more to ask for to have the peace of mind when you send your child to a day care.

I am also writing to you as a fellow colleague of Ms. Lai in providing Chinese language and cultural education to children in the East Bay Area. I am the Head of Shu Ren International School in Berkeley, a Mandarin immersion school currently serving children from age 3 to second grade. In the past two years since I started to work on Shu Ren, I have talked to many parents looking for Mandarin immersion schools at various age levels. Often, they asked about how they could find a quality Mandarin day care for their younger child (we only admit children 3 and older). Over and over again, I recommended Ms. Lai. Undoubtedly, her day care has been an tremendous asset to the city of Albany considering there are not many other large family day cares in Albany, and to the best of my knowledge, her day care is the only Mandarin-

speaking large family day care. Given the surge in interest among parents to teach their children Mandarin, we need more family day cares like Ms. Lai's, not less.

Finally, I like to testify Ms. Lai's character having known her for more than three years. She is honest, dependable, sincere, and trustworthy. She cares deeply about children, their families, and the community. She is very sensitive to neighbors' concerns and willing to work together to solve them. Below I will briefly discuss a couple of potential issues and suggest how they may be addressed.

- 1. <u>Traffic.</u> The large family day care can accommodate 14 children at most. Some live nearby and can walk to her house. In addition, her day care's scheduling is not structured like a school, thus drop-off and pick-up is expected to be scattered throughout the day, reducing the possibility of stacked cars or numerous vehicles at the site. Even if there may be a peak hour of dropping off, a drive-by drop-off can be easily instituted.
- 2. <u>Noise</u>. The effect of noise can be mitigated by moving the play area away from neighbor's house. The site has outdoor play area in all directions which allows the flexibility of only using the section away from the neighbors' house. In addition, children's playtime in the outdoor is usually limited to 1-2 hours a day, thus, the effect is also limited.

In sum, I strongly believe that a large family day care like Ms. Lai's provides very valuable community services to families in the city of Albany and surrounding places and should be continued. There is nothing that cannot be resolved through dialogue and careful planning. Therefore, your approval of her application will be greatly appreciated.

We are writing this letter in support of Mrs. Lai Dezhen and the Albany Family Child Care. Our daughter Lindsey is a kindergartener at Cornell Elementary and attends Albany Family Child Care after school.

Although Lindsey has only been enrolled a short time, she already feels at home with Mrs. Lai, her staff, and the other kids, and we are heartbroken at the thought that she might be wrenched away from this loving environment and her new friends if Mrs. Lai is forced to suspend or reduce her operations.

For working parents, it's always a challenge to find trusted, quality care. Lindsey's language skills - which slipped considerably last year while she attended a non-Chinese preschool - have already improved significantly. Without Mrs. Lai, these would be permanently lost.

We were thrilled when Mrs. Lai announced that she was moving to a new permanent location because the new facility has been thoughtfully planned out and

offers better indoor and outdoor spaces for both the younger and older children. The new location is also much more insulated from surrounding houses and better situated for picking up and dropping off. We're actually quite surprised that there has been a negative reaction from any neighbors, given the nature of this business, the busy street and the close proximity of high-impact areas such as the BART tracks, Solano Avenue and the Albany Senior Center.

That Mrs. Lai has operated successfully for several years in her current location and been well-received by neighbors as well as parents speaks volumes about her ability to cooperate and integrate her needs with others, given the chance. In addition to providing a valuable service to the families who benefit directly from her care and tutelage, Mrs. Lai benefits the larger Albany community by practicing good values and helping to prepare a new generation of children to succeed and prosper in the schools.

Frankly, without Mrs. Lai, our family has no good option for our daughter. Aside from the personal loss and sadness, it will be extremely challenging to find an alternative situation now that school has already begun. Any quality home-based setting or small program is no doubt full and other Chinese language options are non-existent or too far away. Even if space is available at large programs like the YMCA, our daughter will lose her connection to her native language and culture and it will be very difficult for her to transition (for the second time in a month) to a strange environment in which other children have already forged connections.

We hope this letter will help give you a better picture of what is at stake - for our family and many others - as well as the important contribution that the Albany Family Child Care provides to our city. To deny Mrs. Lai's request (and her livelihood) would be a great shame. It would mean the loss of exactly the kind of small, successful, humane and useful business that Albany should support and a blow to education, cultural diversity and the many families who are counting on Mrs. Lai to care for their children.

All working parents know the difficulties of striking a good work/life balance and the heartache of leaving your children in the care of someone else. A paid care option that isn't simply adequate but helps children thrive and grow into caring adults is something we should all treasure and support. We hope you will agree and allow the Albany Family Child Care to continue operating at its new location at 724 Masonic Avenue.

# Dear Commission members,

We are writing to you in support of the Albany Family Child Care, and its proposed relocation to 742 Masonic Avenue, Albany, CA.

Our daughter, Evalena, began attending Mrs. Dezhen Lai's daycare in February 2008 when she was just under 2 years-old. We wanted a good quality daycare in Albany, or its surroundings, that would expose our daughter to the Chinese language. Mrs. Shen of the Cornell Elementary After-school Chinese Program recommended that we contact Mrs. Lai.

We have been impressed by the quality of the care Mrs. Lai and her staff provide to the children, by the efforts Mrs. Lai puts into teaching Chinese to the children under her care, and by her contributions to the fabric of the Albany community. We are also impressed by the efforts she is currently putting in accommodating her future neighbors at the proposed new location of the daycare.

## Quality of the daycare

Mrs.Lai is an experienced teacher with a caring and loving staff. The daycare strives to encourage children to play together, to explore and discover games, to share their new experiences, and to develop emotionally, psychologically and physically.

## Chinese Cultural Environment

The daycare makes an important contribution to our daughter's education by providing an environment where the Chinese language is spoken, Chinese culture is presented through music, songs and dances, and the Chinese script is introduced through books, games and drawings.

Many children attending Mrs. Lai's daycare already speak Chinese at home; our family is not a Chinese-speaking household. Mrs. Lai's daycare is our daughter's only opportunity to play and learn in an environment where Chinese is used. We are thankful that Mrs. Lai and her staff have welcomed Evalena and are striving to teach her Chinese.

# Proximity of the daycare to families' homes

Mrs. Lai provides quality daycare near the children and their working parents' homes. Many of us are Albany residents. It is of great value to us that Mrs. Lai' daycare is located in Albany. Discontinuing the operations of the daycare in the City of Albany would seriously disrupt our lives, and the lives of many other Albany families and families in nearby communities.

Fabric of the Albany Community

Since beginning its operations on Stannage Ave several years ago, the Albany Family Child Care has become an integral part of the fabric of Albany's society. It has made important contributions to the Albany community through its participations in Chinese festivals celebrated in Albany and through its visits to the Albany Senior Center. We are proud of the daycare for extending its services to the wider Albany Community, and for teaching our child the value of civic service.

New proposed location

The proposed new childcare facility will benefit our child through its bright indoor layout and its outdoors play area.

We understand that neighbors may be concerned with parking or noise. We are impressed by the efforts that Mrs. Lai has made to accommodate those concerns:

- In terms of parking, we believe that there ought not to be any problem. There is ample parking on side streets, in addition to available parking on the Eastern side of Masonic Ave, under the BART rails. Our family often goes on foot or bicycle to Mrs. Lai's daycare, we plan to continue doing so, lowering our impact on the daycare's neighborhood.
- In terms of noise, Mrs. Lai has made plans to keep the children away from her close neighbors. A fence and a wall separate her property from her Western neighbor on Washington Ave. A wall also separates her property from her Northern neighbor on Masonic Ave. While this wall does not extend the length of the property line, Mrs. Lai has told us personally of plans to have potted plants or other barriers extended along the length of the property line. She will also direct the children to play away from that area—indeed, she has already redrawn her outdoors playground area to keep the children away.

Mrs. Lai has maintained good relations with her current neighbors at Stannage Ave; several of her neighbors have personally told us so. We are convinced that Mrs. Lai will make efforts to maintain good relations with her new neighbors on Masonic and Washington Ave.

As a conclusion, we would like to stress the importance of allowing the Albany Family Child Care to continues its operation in Albany. We have chosen to live in Albany because of its high reputation in educating children, we believe that Mrs. Lai's daycare is an integral part of the quality of education that Albany offers to its children.

We respectfully request that the City of Albany allow the Albany Family Child Care to continue its operation at the new proposed location on 742 Masonic Avenue. It is a location that will benefit the children and their families, and allow the childcare to continue its active participation in the community life of Albany
